WILSON GABOR ) REPRIMAND AND PROBATION 6 7 On October 3, 2023, the Teacher Standards and Practices Commission (Commission) 8 received a School District Misconduct Report from the Gervais School District (District) 9 alleging possible professional misconduct on Justin P. Wilson Gabor (Wilson Gabor). 10 After review of the matters alleged, Wilson Gabor and the Commission agree that their 11 respective interests, together with the public interest, are best served by a stipulation to certain 12 facts and the imposition of a Public Reprimand and Probation of Wilson Gabor's Oregon 13 educator license. 14 This Order sets forth the facts upon which the parties have agreed and the sanction to be 15 imposed stipulates that there are sufficient facts contained in the Commission's files and records 16 to support the findings of fact and conclusions of law set forth below. In entering into this 17 stipulation, Wilson Gabor waives the right to a hearing to contest the findings of fact, 18 conclusions of law and order set forth below. 19 By signing below, Wilson Gabor acknowledges, understands, stipulates, and agrees to the 20 following: (i) he has been fully advised of his rights to notice and a hearing to contest the 21 findings of fact, conclusions of law, and order set forth below, and fully and finally waives all 22 such rights and any rights to appeal or otherwise challenge this Stipulation of Facts and Final 23 Order of a Public Reprimand and Probation of licensure (Stipulation and Final Order); (ii) this 24 Stipulation and Final Order is a public document and disclosed to the public upon request by the 25 Commission; (iii) this Stipulation and Final Order is contingent upon and subject to approval 26 and adoption by the Commission. If the Commission does not approve and adopt this 27 Stipulation and Final Order, then neither Wilson Gabor nor the Commission are bound by the 28 terms herein; (iv) he has fully read this Stipulation and Final Order, and understands it 29 completely; (v) he voluntarily, without any force or duress, enters into this Stipulation and Final 30 Order and consents to issuance and entry of the Stipulated Final Order below; (vi) he states that 31 no promise or representation has been made to induce him to sign this Stipulation and Final 32 Order; and (vii) he has consulted with an attorney regarding this Stipulation and Final Order 33 and has been fully advised with regard to his rights thereto or waives any and all rights to

consult with an attorney prior to entering into this Stipulation and Final Order and issuance and

entry of the Stipulated Final Order below.

1. The Commission has licensed Wilson Gabor since February 8, 2011. Wilson Gabor holds a Preliminary Teaching License with an endorsement in English Language Arts (PK-12), valid from March 27, 2023, through July 6, 2026. Wilson Gabor also holds a Principal License with an endorsement in Principal (PK-12), valid from March 27, 2023, through July 6, 2026. Wilson Gabor applied for an additional endorsement to his educator licenses on August 28, 2024, which remains pending. During all relevant times Wilson Gabor was employed with either the Gervais School District (GSD), the Greater Albany Public Schools (GAPS), or Salem-Keizer School District (SKSD).

On October 3, 2023, the Commission received a misconduct report from the GSD. The
report alleged Wilson Gabor directed inappropriate communications, in person and
electronically, to students and staff.

3. Investigation found that on September 8, 2023, Wilson Gabor was placed on administrative leave by the GSD while the District investigated an allegation Wilson Gabor acted unprofessionally the previous day. On September 14, 2023, Wilson Gabor resigned and separated from the district. Approximately one week later, Wilson Gabor accepted a teaching position with GAPS and began teaching on September 28, 2023. On October 2, 2023, Wilson Gabor separated from GAPS.

4. Investigation found that on September 26, 2023, approximately two weeks after Wilson Gabor's resignation from the GSD, Wilson Gabor sent a text message to his former supervisor questioning the supervisor's maturity. On September 26, 2023, Wilson Gabor sent a text to his former supervisor and two female district staff members. The text included some profanity and unprofessional comments directed at the three staff members. On June 1, 2024, Wilson Gabor sent a group text message to his former supervisor and the two staff members. The message included a risque photo and text commenting that the three staff members resemble people in the photo.

 Investigation found that on September 14, 2023, Wilson Gabor electronically applied for employment with SKSD. The application included a section of character questions.
 Wilson Gabor omitted and failed to fully disclose information regarding his separation from the GSD.

1 6. Investigation found that on September 19, 2023, Wilson Gabor electronically applied for 2 employment with GAPS. The application included a section of character questions. 3 Wilson Gabor omitted and failed to fully disclose information regarding his separation 4 from the GSD. 5 6 7. Investigation found on October 3, 2023, Wilson Gabor submitted an application for 7 employment with SKSD. The application included a section of character questions. 8 Wilson Gabor omitted and failed to fully disclose information regarding his separation 9 from the GSD. 10 11 8. Investigation found on October 12, 2023, the Commission sent Wilson Gabor a letter by 12 certified mail notifying him he was under investigation by the Commission, On October 13 25, 2023, Wilson Gabor contacted Commission staff via email, acknowledging the 14 Commission's investigation and to provide supplemental information. 15 9. Investigation found on April 26, 2024, and August 28, 2024, Wilson Gabor submitted 16 17 applications for employment with SKSD. The application included a section of character 18 questions. Wilson Gabor omitted and failed to fully disclose information regarding his 19 separation from the GSD and that he was under investigation by the Commission. 20 21 10. Investigation determined that on August 28, 2024, Wilson Gabor electronically applied 22 for an Endorsement for English to Speakers of Other Language to be added to his current 23 licensure. The application included a section of character questions. | 17 | conclusions of law, and based thereon, imposes a Public Reprimand on Justin P. Wilson Gabor's   |
| 18 | Oregon educator license.  |
| 19 | Furthermore, the Commission imposes a one (1) year period of probation upon Wilson              |
| 20 | Gabor's licensure to commence upon adoption of this order, and subject to the following         |
| 21 | condition:  |
