On January 12, 2026, the Teacher Standards and Practices Commission (Commission) issued a Notice of Opportunity for Hearing to Brian A. Hoogendijk (Hoogendijk) in which the Commission charged him with Gross Neglect of Duty. The Notice was sent via U.S. First Class Mail and U.S. Certified Mail Receipt 9589 0710 5270 2978 6276 06 to Hoogendijk's last known address on file with the Commission. Additional copies were mailed to Hoogendijk's attorney of record. The Notice designated the Commission file as the record for purposes of proving a prima facie case. The Notice was returned as confirmed "delivered" on January 21, 2026. The Notice of Opportunity of Hearing, dated January 12, 2026, and signed by Rachel Alpert, Executive Director, stated:

"IF A REQUEST FOR HEARING IS NOT RECEIVED WITHIN THIS 21-DAY PERIOD, YOUR RIGHT TO A HEARING SHALL BE CONSIDERED WAIVED UNLESS YOUR FAILURE TO REQUEST A HEARING WAS BEYOND YOUR REASONABLE CONTROL. IF YOU DO NOT REQUEST A HEARING, WITHDRAW YOUR REQUEST FOR HEARING, OR IF YOU FAIL TO APPEAR AT A HEARING, OR NOTIFY THE COMMISSION THAT YOU WILL NOT APPEAR AT HEARING, THE COMMISSION WILL ADOPT AN ORDER OF DEFAULT WHICH MAY INCLUDE THE REVOCATION OR SUSPENSION OF YOUR LICENSE OR OTHER DISCIPLINE."

On January 28, 2026, the Commission was notified by Hoogendijk's attorney, Caitlin Kauffman, that Hoogendijk would be allowing the case to default. The Commission, therefore, finds Hoogendijk to be in default and enters the following findings of fact, conclusions of law, and final order, based on the files and records of the Commission concerning this matter.

**FINDING OF FACT**

1. The Commission has licensed Hoogendijk since January 13, 2013. Hoogendijk currently holds a Preliminary Teaching License with endorsements in Biology (PK-12), Legacy Middle Level (PK-12), Business/Management Admin CTE (PK-12), Business/Management Marketing CTE (PK-12), and Finance CTE (PK-12). The license was issued on April 16, 2024, and expires on September 26, 2027. During all relevant times, Hoogendijk was employed by the Nestucca Valley School District (NVSD).

2. On April 24, 2024, the Commission received a School District Misconduct Report from the NVSD. The report alleges that Hoogendijk, a licensed educator, engaged in professional misconduct. Specifically, misconduct report alleges that Hoogendijk engaged in sexual conduct with a student (student A) between October 24, 2023 and April 19, 2024.
3. On or about May 9, 2024, Hoogendijk was arraigned in Tillamook County Circuit Court on multiple counts of Sexual Abuse III. On September 25, 2025, Hoogendijk was found guilty of three (3) counts of Sexual Abuse III (ORS 163.415). On October 17, 2025 he was sentenced to sixty (60) months of supervised probation, thirty (30) days incarceration, no contact with the victim, a sex offender evaluation and treatment and no contact with females under the age of 18. Additionally, he was ordered not to go to places where minor children are found to congregate (schools, playgrounds, arcades, parks, etc.) and were ordered to register as a sex offender under ORS 163A.010 or 163A.015, if required.

Based on the criminal conviction as alleged above, the Commission is required to revoke Hoogendijk's license under ORS 342.175(3).

### **CONCLUSIONS OF LAW**

*The conduct described above in section three (3) constitutes gross neglect of duty in violation of ORS 342.175(1)(b); OAR 584-020-0040(4)(f) (Any sexual conduct with a student) as defined by OAR 584-020-0005(8) and ORS 339.370(12)(a).*

*Additionally, the conduct described above in section three (3) constitute gross neglect of duty in violation of ORS 342.175(1)(b); OAR 584-020-0040(4)(n) as it incorporates OAR 584-020-0010(1) (Recognize the worth and dignity of all persons and respect for each individual), OAR 584-020-0010(5) (Use professional judgment), OAR 584-020-0025(2)(e) (Using district lawful and reasonable rules and regulations), and This conduct also constitutes gross unfitness in violation of ORS 342.175(1)(c); OAR 584-020-0040(5)(c)*

*(Conviction of violating any federal, state, or local law. A conviction includes any final judgment of conviction by a court whether as the result of guilty plea, no contest plea or any other means); OAR 584-020-0040(5)(d) and OAR 584-020-0040(5)(e) (Admission of or engaging in acts constituting criminal conduct, even in the absence of a conviction).*

*The Commission's action is also based on OAR 584-20-0040(1) (The Commission will deny, revoke or deny the right to apply for a license or charter school registration to any applicant or educator who, has been convicted of any of the crimes listed in ORS 342.143, or the substantial equivalent of any of those crimes if convicted in another jurisdiction), including Sexual Abuse III (ORS 163.415).*

The Commission's authority to impose discipline in this matter is based upon ORS 342.175.

### **FINAL ORDER**

The Commission hereby revokes Hoogendijk's Oregon teaching license and revokes his right to apply for a license.
