

1 **STIPULATION OF FACTS**

- 2 1. The Commission has licensed Jarvis since September 11, 1995. Jarvis holds a
3 Professional Teaching License, with endorsements in Elementary - Multiple Subjects
4 (PK-12), Career Trades - Generalist (PK-12), Legacy Middle Level (PK-12), valid from
5 January 6, 2022, through February 4, 2027. During all relevant times, Jarvis was
6 employed by the Riddle School District (RSD).
7
- 8 2. On March 14, 2025, the Commission received a school misconduct report from the RSD
9 indicating Jarvis may have committed acts of gross neglect of duty and/or gross
10 unfitness. Specifically, the report contained an allegation that Jarvis had violated
11 teacher/student boundaries.
12
- 13 3. Investigation found that between the 2020-21 and 2024-25 school year, Jarvis instructed
14 a female student in one of his shop classes at Riddle Junior/Senior High School. Jarvis
15 began following the student on social media on the student’s Instagram and Snapchat
16 accounts when she was fourteen years of age. On an unspecified date, Jarvis commented
17 to the student when she was fourteen years of age, at the Riddle Junior/Senior High
18 School, that her stomach was “sexy”. Jarvis mistakenly sent the student the comment,
19 “damn that picture is fucking hot” to a photo of the student in gym class which she
20 posted on Instagram when she was seventeen years of age.

36 **CONCLUSION OF LAW**

37 Shan A. Jarvis’ conduct as described in section three (3) above constitutes gross neglect
38 of duty in violation of ORS 342.175(1)(b); OAR 584-020-0040(4)(n) as it incorporates, OAR

1 584-020-0010(5) (*Use professional judgment*), and OAR 584-020-0030(2)(b) (*Skill in*
2 *communicating with administrators, students, staff, parents and other patrons*); and OAR
3 584-020-0040(4)(o) as it incorporates OAR 584-020-0035(1)(c)(A) (*Not demonstrating or*
4 *expressing professional interest in a student's personal life.*) and OAR 584-020-
5 0035(1)(c)(D) (*Honoring appropriate adult boundaries with students in conduct and*
6 *conversations at all times*).

7 The Commission's authority to impose discipline in this matter is based upon ORS
8 342.175.

10 **ORDER**


11 The Commission adopts and incorporates herein the above findings of fact and
12 conclusions of law, and based thereon, imposes a thirty (30) day Suspension upon Shane A.
13 Jarvis' Oregon educator license.

14 Furthermore, the Commission imposes a three (3) year period Probation upon Jarvis'
15 license to commence upon reinstatement of Jarvis' license and subject to the following
16 conditions:

- 17 1. Jarvis shall comply with the Standards for Competent and Ethical Performance of
18 Oregon Educators under Oregon Administrative Rules Chapter 584, Division 020.
- 19 2. Prior to reinstatement, Jarvis shall successfully complete a Commission-approved
20 training course on teacher/student boundaries and provide evidence to the
21 Commission of such trainings.
