1 BEFORE THE TEACHER STANDARDS AND PRACTICES COMMISSION 2 OF THE STATE OF OREGON 3 4 **DEFAULT ORDER OF** In the Matter of the Educator) 5 License of **REPRIMAND** 6 **ROLF ALAN ADAMS** 7 8 On January 9, 2015, the Teacher Standards and Practices Commission (Commission) 9 issued a Notice of Opportunity for Hearing to Rolf Alan Adams (Adams) in which the 10 Commission charged him with Gross Neglect of Duty. The Notice was sent via U.S. First 11 Class Mail and U.S. Certified Mail Receipt 7014 0150 0000 6070 0441 to the address on file 12 with the Commission. The Notice designated the Commission file as the record for purposes 13 of proving a prima facie case. The Certified Mail receipt was returned to the Commission 14 "signed" on January 14, 2015. The first class mail was not returned to the Commission. The 15 Notice of Opportunity of Hearing, dated January 8, 2015, and signed by Victoria 16 Chamberlain, Executive Director, stated: 17 "IF A REOUEST FOR HEARING IS NOT RECEIVED WITHIN THIS 21-DAY 18 PERIOD, YOUR RIGHT TO A HEARING SHALL BE CONSIDERED WAIVED 19 UNLESS YOUR FAILURE TO REQUEST A HEARING WAS BEYOND YOUR 20 21 REASONABLE CONTROL. IF YOU DO NOT REQUEST A HEARING OR IF YOU FAIL TO APPEAR AT A HEARING, THE COMMISSION WILL ADOPT AN ORDER 22 OF DEFAULT WHICH MAY INCLUDE THE REVOCATION OR SUSPENSION OF 23 24 YOUR LICENSE OR OTHER DISCIPLINE." 25 Adams did not request a hearing. The Commission, therefore, finds Adams to be in default 26 27 and enters the following findings of fact, conclusions of law, and final order, based on the files and records of the Commission concerning this matter. 28 29 FINDINGS OF FACT 1. The Commission has licensed Adams since September 09, 1993. Adams holds a 30 Substitute Teaching License, with an endorsement in Substitute Any Specialty (PP-31 12), valid from November 30, 2014, through November 29, 2017. Adams previously 32 held a Basic Teaching License, with an endorsement in Basic Advanced Mathematics 33 (019), valid from November 8, 2011, until it expired on November 29, 2014. During 34 all relevant times. Adams was employed as a substitute teacher by the Reynolds 35 School District. 36

2. On June 10, 2014, the Commission received a report from the superintendent of the Reynolds School District indicating that Adams had violated professional standards. School district investigation determined Adams engaged inappropriate physical contact with a student that caused the student pain. As a result, the school district removed Adams from their substitute teacher list.

6 7 3. Commission investigation determined that on or about April 8, 2014, Adams was 8 substitute teaching at the Hartley Elementary School for a second grade classroom. During Adams' instruction, Adams told the students that if he gestured by shaking 9 his fists in the air or made a choking gesture with his hands, that he was not 10 threatening them, that is just how he communicates. Adams discussed the topic of 11 fighting with the classroom. Adams explained to the six and seven year old students 12 that an alternative to a fist fight was to use wrestling techniques to pin or control 13 someone. Adams selected MH as a student to demonstrate such a wrestling move 14 upon. MH was a Farsi speaking refugee from Afghanistan whose surviving family 15 had escaped to asylum in America. MH spoke little to no English and could not 16 17 understand Adams' actions. Adams physically applied the wrestling move to MH, resulting in Adams manipulating MH by the head and neck and pinning MH to the 18

language barrier prior to engaging in these activities.

Rolf Alan Adams engaged in unprofessional conduct as described above. This conduct constitutes Gross Neglect of Duty in violation ORS 342.175(1)(b); OAR 584-020-0040(4)(n) as it incorporates OAR 584-020-0020(0010(1)(Recognize the worth and dignity of all persons and respect for each individual), OAR 584-020-0010(5) (Use professional judgment), OAR 584-020-0020(2)(d)(Skill in the supervision of students), OAR 584-020-0030(2)(b) (Skill in communicating with administrators, students, staff,
