Teaching License of) ORDER OF REVOCATION OF
DONALD HUGH MEIKLE) TEACHING LICENSE

On February 11, 2011, the Commission issued a Default Order of Revocation of Teaching License to Donald Hugh Meikle. Due to a clerical error in the Default Order, the Commission hereby issues this Corrected Final Order .

On December 1, 2010, the Teacher Standards and Practices Commission (Commission) issued a Notice of Opportunity for Hearing to Donald Hugh Meikle (Meikle) in which the Commission charged him with Gross Neglect of Duty pursuant to OAR 584-020-0040(4)(n), OAR 584-020-0010 (5), OAR 584-020-0040(5)(e), OAR 584-020-0040(1)(m), OAR 584-020-0040(1)(s), OAR 584-020-0040(1)(II), OAR 584-020-0040(1)(mm). The Notice was sent via U.S. First Class Mail and U.S. Certified Mail Receipt 7010 0290 0001 6831 4701 to the address on file with the Commission. The regular mail was not returned to the Commission. Meikle signed for the certified mail on December 6, 2010. The Notice of Opportunity of Hearing, dated December 1, 2010, and signed by Victoria Chamberlain, Executive Director, stated:

“IF A REQUEST FOR HEARING IS NOT RECEIVED WITHIN THIS 21-DAY PERIOD, YOUR RIGHT TO A HEARING SHALL BE CONSIDERED WAIVED UNLESS YOUR FAILURE TO REQUEST A HEARING WAS BEYOND YOUR REASONABLE CONTROL. IF YOU DO NOT REQUEST A HEARING OR IF YOU FAIL TO APPEAR AT A HEARING, THE COMMISSION WILL ADOPT AN ORDER OF DEFAULT WHICH MAY INCLUDE THE REVOCATION OR SUSPENSION OF YOUR LICENSE OR OTHER DISCIPLINE.”

Meikle did not request a hearing. The Commission, therefore, finds Meikle to be in default and enters the following findings of fact, conclusions of law and order, based on the files and records of the Commission concerning this matter.

FINDINGS OF FACT

1. Douglas Hugh Meikle has been licensed as a teacher in Oregon by the Commission since April 13, 1987. Meikle's Initial Administrator License, issued on April 2, 2008, expires on August 4, 2014. Meikle's Standard Teaching License issued September 1, 2009, with a Basic Elementary endorsement, expires on August 4, 2011.
2. On December 9, 2009, Meikle was interviewed by Portland Police regarding allegations that Meikle frequented the SE 82nd Avenue area of Portland in an effort to engage the services of prostitutes. During this interview Meikle admitted that he frequented the area in question for the purpose of prostitution, and that Meikle had allowed two prostitutes, SN and JR live with him. During the time that JR lived with Meikle, she was approximately 16 years old. During Meikle's interview with Portland Police he stated that he had sex with both SN and JR while they lived with him.
3. JR reported to her DHS caseworker that while she lived with Meikle, he asked her to help with bills and expenses and that Meikle expected her to prostitute in order to contribute to the household finances.

CONCLUSIONS OF LAW

Donald Hugh Meikle' conduct described in paragraphs 2 and 3 above constitutes gross neglect of duty and gross unfitness in violation of ORS 342.175(1)(b) and ORS 342.175(1)(c); OAR 584-020-0040(4)(n) as it incorporates OAR 584-020-0010(5) (*Use professional judgment*); and OAR 584-020-0040(5)(e) (*Admission of or engaging in acts constituting criminal conduct, even in the absence of a conviction*) specifically: OAR 584-020-0040(1)(m) (ORS 163.415 -- *Sexual Abuse in the Third Degree*), OAR 584-020-0040(1)(s) (ORS 163.445 -- *Sexual Misconduct*), OAR 584-020-0040(1)(kk) (ORS 167.007 -- *Prostitution*), OAR 584-020-0040(1)(ll) (ORS 167.012 -- *Promoting Prostitution*), and OAR 584-020-0040(1)(mm) (ORS 167.017 -- *Compelling Prostitution*).

5 License and his Standard Teaching License effective February 11, 2011.
