9	On June 28, 2013, the Teacher Standards and Practices Commission (Commission)
10	issued a Notice of Opportunity for Hearing to Kelly Brent Kubicek (Kubicek) in which the
11	Commission charged him with Gross Neglect of Duty. The Notice was sent via U.S. First
12	Class Mail and U.S. Certified Mail Receipt 7011 2000 0001 1282 3763 to the address on file
13	with the Commission. The Notice designated the Commission file as the record for purposes
14	of proving a prima facie case. The Certified Mail receipt was returned, signed to the
15	Commission on July 1, 2013. The regular mail was not returned to the Commission. The
16	Notice of Opportunity of Hearing, dated June 28, 2013, and signed by Victoria Chamberlain
17	Executive Director, stated:

IF YOU DO NOT REQUEST A HEARING OR IF YOU FAIL TO APPEAR AT A HEARING, THE COMMISSION WILL ADOPT AN ORDER OF DEFAULT WHICH MAY INCLUDE THE REVOCATION OR SUSPENSION OF YOUR LICENSE OR OTHER DISCIPLINE."
26	Kubicek did not request a hearing. The Commission, therefore, finds Kubicek to be in
27	default and enters the following findings of fact, conclusions of law, and final order, based
28	on the files and records of the Commission concerning this matter.
29	FINDINGS OF FACT
30	1. Kelly Brent Kubicek made application to the Commission and was approved for his
31	Student Teaching / Practicum on December 13, 2011. Kubicek does not currently hold a
32	Teaching License. During all relevant times, Kubicek was not known to be employed by
33	any Oregon School District.
34	2. On June 5, 2012, the Commission learned that on June 3, 2012, Kubicek had been
35	arrested for Possession of a Controlled Substance II, a class C felony, Failure to
36	perform the duties of a driver, and Resisting Arrest. The Commission further learned
37	that on August 22, 2012, Kubicek was convicted of Failure to Perform the Duties of a

Driver as a violation; Kubicek was given a conditional discharge for the charge Possession of a Controlled Substance; and the charge of Resisting Arrest was dismissed. Records indicate Kubicek also has a prior arrest record for Unlawful Possession of Marijuana, Reckless Driving, and Attempting to Elude Police on March 20, 2008. On August 8, 2008, Kubicek was convicted of the Attempt to Elude Police charge as a felony, while the other charges were dismissed. Kubicek was sentenced to ten days in jail and 18 months probation. On March 22, 2011, Kubicek's felony conviction was reduced to a Misdemeanor offence. Commission investigators attempted to contact and interview Kubicek regarding these incidents. Official written requests for an interview were sent to Kubicek both by certified and regular mail. The certified receipt was returned signed for on September 4, 2012, and the regular mail was not returned and assumed delivered. Kubicek failed to contact or cooperate with the investigators as required.

CONCLUSIONS OF LAW

Kubicek's conduct constitutes gross neglect of duty in violation of ORS 342.175(1)(b); OAR 584-020-0040(4)(n) as it incorporates OAR 584-020-0010(5) (*Use professional judgment*). This conduct also constitutes gross unfitness in violation of ORS 342.175(1)(c); OAR 584-020-0040(5)(p) (*Subject to the exercise of any legal right or privilege, failure or refusal by an educator under investigation to respond to requests for information, to furnish documents or to participate in interviews with a Commission representative relating to a Commission investigation*), and OAR 584-020-0040(5)(c) (*Conviction of violating any federal, state, or local law. A conviction includes any final judgment of conviction by a court whether as the result of guilty plea, no contest plea or any other means*). Kubicek's past criminal conduct is also evidence that Kubicek lacks good moral character or mental/physical fitness to serve as an educator as required under ORS 342.143(2).

The Commission's authority to impose discipline in this matter is based upon ORS
