1 BEFORE THE TEACHER STANDARDS AND PRACTICES COMMISSION OF THE STATE OF OREGON In the Matter of the DEFAULT ORDER OF 5 Teaching License of LICENSE REVOCATION AND JUSTIN MICHAEL SMITH REVOCATION OF RIGHT TO 6 APPLY FOR A LICENSE 7 8 9 On August 5, 2003, the Teacher Standards and Practices Commission (Commission) 10 issued a Notice of Opportunity for Hearing to Justin Michael Smith (Smith) in which the 11 Commission charged him with conviction of a crime listed in ORS 342.143(3). The Notice was 12 sent via U.S. First Class Mail and U.S. Certified Mail Receipt 7002 3150 0004 3439 2377 to the 13 address obtained by the Commission. The certified mail receipt was signed by R. Rydon, agent 14 for the Coffee Creek Correctional Facility. The Notice of Opportunity of Hearing, dated August 15 5, 2003, and signed by Victoria Chamberlain, Executive Director, stated: 16 "You, Justin Michael Smith, are entitled to a hearing on the proposed action of the Commission. If you want a hearing, you must file a written request for a 17 hearing with the Commission within 21 days of the date of this notice. Attached to this notice is a copy of the procedures, right of representation and other rights of parties relating to the conduct of a hearing as required under ORS 20 183.413(2)." 21 22 23 Mr. Smith did not request a hearing. The Commission, therefore, finds 24 Mr. Smith to be in default and enters the following findings of fact, conclusions of law 25 and order, based on the files and records of the Commission concerning this matter. 26 **FINDINGS OF FACT** 27 1. Mr. Smith holds a Standard Teaching License issued April 5, 2000, valid until June 18, 2005. 28 2. Mr. Smith served as a substitute teacher for the Umatilla-Morrow Education Service 29 30 District from February 14, 2000, to December 5, 2001. 31 3. On February 24, 2003, Justin Michael Smith was convicted of two counts of Sexual 32 Abuse II, ORS 163.425, in the Circuit Court of the State of Oregon for Umatilla County.

## 1 **CONCLUSIONS OF LAW** The crime of Sexual Abuse II as defined in ORS 163.425 is listed in ORS 342.143(3). 3 The Commission is required to revoke the Oregon Standard Teaching License issued to Justin 4 Michael Smith and revoke his right to apply for a license pursuant to ORS 342.175(2). 5 **ORDER** 6 The Commission hereby revokes the Oregon Standard Teaching License issued to 7 Justin Michael Smith, also known as John Harold Kuchler, and revokes his right to apply for a 8 teaching license.
