10	On July 31, 2000, the Teacher Standards and Practices Commission issued a Notice of
11	Opportunity for Hearing to Gene Darrell Slayter in which the Commission proposed to suspend
12	or revoke the teaching license of Gene Darrell Slayter or otherwise impose discipline under ORS
13	342.177. The notice was sent via U.S. First Class Mail and U.S. Certified Mail Receipt Z 204
14	897 234. The certified mail receipt was signed and dated by Gene Slayter on August 3, 2000.
15	The Notice of Opportunity for Hearing signed by David V. Myton, Executive Director, stated:
16	
17	"You, Gene Darrell Slayter, are entitled to a hearing on the proposed action of the
18	Commission. If you want a hearing, you must file a written request for a hearing
19	with the Commission within 21 days of the date of this notice."
20	
21	Based on the foregoing, the Commission finds Mr. Slayter in default and such default is hereby
22	entered. Based on the records and files of the Commission, the Commission enters the following
23	findings of fact and order.

26	FINDINGS OF FACT
27	
28	1. On June 1, 2000, Gene Darrell Slayter was found guilty of the crime of Sexual Abuse in the
29	Third Degree – Count 1.

37	Gene Darrell Slayter's license is hereby revoked on the grounds that he was convicted of the
38	crimes of Sexual Abuse III and Attempted Sexual Abuse III – OAR 584-020-0040(1).

43	Mr. Slayter's contact with students was the result of his position as a teacher. His conduct
44	violated professional ethics of licensed educators.
