The Notice was 11 12 sent via U.S. Certified Mail Receipt #7002 3150 0004 3437 3437 to the address obtained by the Commission. The certified mail receipt was signed by Tami A. Kelley, agent for Coffee Creek 13 Correctional Facility and returned to the Commission on February 24, 2004. The Notice of 14 Opportunity of Hearing, dated February 19, 2004, and signed by Victoria Chamberlain, 15 16 Executive Director, stated: "You, Adam Ornelas Campos, are entitled to a hearing on the proposed action of the Commission. If you want a hearing, you must file a written request for a hearing with the Commission within 21 days of the date of this notice. Attached 19 to this notice is a copy of the procedures, right of representation and other rights 20 of parties relating to the conduct of a hearing as required under ORS 21 183.413(2)." 22 23 Mr. Campos did not request a hearing. The Commission, therefore, finds 24 25 Mr. Campos to be in default and enters the following findings of fact, conclusions of law and order, based on the files and records of the Commission concerning this matter. 26 FINDINGS OF FACT 27

1. Mr. Campos holds an Initial Teaching License issued August 27, 2003, valid until
May 9, 2007.

2. Mr. Smith served as a teacher for Portland Public Schools from August 29, 2000, until placed on unpaid administrative leave effective December 2, 2003.

1	3. On January 29, 2004, Adam Ornelas Campos was convicted of two counts of
2	Unlawful Sexual Penetration I, ORS 163.411, and Sodomy I, ORS 163.405 in the Circuit Court
3	of the State of Oregon for the County of Yamhill.
4	CONCLUSIONS OF LAW
5	The crimes of Unlawful Sexual Penetration I as defined in ORS 163.411 and Sodomy I
6	as defined in ORS 163.405 are listed in ORS 342.143(3). The Commission is required to
7	revoke the Oregon Initial Teaching License issued to Adam Ornelas Campos and revoke his
8	right to apply for a license pursuant to ORS 342.175(2).
9	ORDER
10	The Commission hereby revokes the Oregon Initial Teaching License issued to Adam
11	Ornelas Campos and revokes his right to apply for a teaching license.
