DEFAULT ORDER OF
LICENSE REVOCATION

"You, Kodiak Jack Malmstrom, are entitled to a hearing on the proposed action of the Commission. If you want a hearing, you must file a written request for a hearing with the Commission within 21 days of the date of this notice. Attached to this notice is a copy of the procedures, right of representation and other rights of parties relating to the conduct of a hearing as required under ORS 183.413(2)."

FINDINGS OF FACT

2. Mr. Malmstrom was employed as a health/PE teacher and coach by the South Lane School District for the years 2002-2003 and 2003-2004. Mr. Malmstrom resigned his teaching position effective the end of the 2003-2004 school year.

3. On July 29, 2004, the Commission adopted a Stipulation of Facts, Order of Reprimand and Probation. The Commission imposed a three-year probation which required bi-annual reports of compliant with an alcohol treatment plan.

4. On or before January 1, 2005, Mr. Malmstrom failed to make a report to the Executive Director of his compliance with his treatment plan pursuant to the Stipulation of Facts and Order of Probation adopted by the Commission on July 29, 2004.

CONCLUSIONS OF LAW

Kodiak Jack Malmstrom violated terms and conditions of an Order of Reprimand and Probation adopted by the Commission on July 29, 2004, in violation of OAR 584-020-0040(4)(k). This behavior constitutes Gross Neglect of Duty. The Commission's authority to impose discipline in this matter is based upon ORS 342.175.

ORDER

The Commission hereby revokes the Restricted Transitional Teaching License issued to Kodiak Jack Malmstrom.
