STURGESS 7 8 9 On October 21, 2022, the Teacher Standards and Practices Commission 10 (Commission) issued a Notice of Opportunity for Hearing to Kory L. Sturgess, (Sturgess) 11 in which the Commission charged him with Gross Neglect of Duty and /or Gross Unfitness. The Notice was sent via U.S. First Class Mail and U.S. Certified Mail Receipt 12 13 7021 0350 0000 8481 3958 to the address on file with the Commission. The Notice 14 designated the Commission file as the record for purposes of proving a prima facie case. 15 The regular first-class mail was not returned to the Commission and assumed delivered. The Notice of Opportunity of Hearing, dated October 21, 2022, and signed by Anthony 16 17 Rosilez, Executive Director, stated: 18 19 "IF A REOUEST FOR HEARING IS NOT RECEIVED WITHIN THIS 21-DAY PERIOD, YOUR RIGHT TO A HEARING SHALL BE CONSIDERED WAIVED 20 21 UNLESS YOUR FAILURE TO REQUEST A HEARING WAS BEYOND YOUR REASONABLE CONTROL. IF YOU DO NOT REQUEST A HEARING, 22 WITHDRAW YOUR REQUEST FOR HEARING, OR IF YOU FAIL TO APPEAR 23 24 AT A HEARING, OR NOTIFY THE COMMISSION THAT YOU WILL NOT APPEAR AT HEARING, THE COMMISSION WILL ADOPT AN ORDER OF 25 DEFAULT WHICH MAY INCLUDE THE REVOCATION OR SUSPENSION OF 26 27 YOUR LICENSE OR OTHER DISCIPLINE." 28 29 As of November 16, 2022, TSPC has received no response from Sturgess. The 30 Commission, therefore, finds Sturgess to be in default and enters the following findings of fact, conclusions of law, and final order, based on the files and records of the 31 32 Commission concerning this matter. 33 1. The Commission has licensed Sturgess since August 17, 2017. Sturgess currently 34 holds a Preliminary Teaching License with an endorsement in Advanced 35 Mathematics (PK-12). The license was issued on August 29, 2019 and expired on 36 37 November 11, 2022. During all relevant times, Sturgess was employed by the Coquille School District (CSD). 38

• On May 10, 2022, Sturgess was indicted by a grand jury in the Circuit Court for Coos County for 15 counts of Encouraging Child Sex Abuse in the 1st degree and 15 counts of Encouraging Child Sex Abuse in the 2nd degree.

 On May 13, 2022, Sturgess was arrested on these charges and lodged at the Coos County Jail.

 On August 12, 2022, Sturgess appeared in the Coos County Circuit Court for sentencing. Sturgess plead guilty to four counts of Encouraging Child Sex Abuse in the 1st degree and was sentenced to 35 months incarceration, 36 months post-prison supervision, and ordered to register as a sex offender.

4. On August 16th, 17th, and 25th, 2022, TSPC sent a request to interview letter to Sturgess via both regular and certified mail. The letters were received by Sturgess on August 27, 2022 as confirmed by the USPS return receipt. As of the writing of this Notice of Hearing, TSPC has yet to receive a response from Sturgess.

Under ORS 342.175(2) and OAR 584, Division 020, the Commission will deny, revoke or deny the right to apply for a license or charter school registration to any applicant or educator who, has been convicted of any of the crimes listed in ORS 342.143, or the substantial equivalent of any of those crimes if convicted in another jurisdiction or convicted of attempt to commit such crimes as defined in 161.405.

CONCLUSIONS OF LAW

Under ORS 342.175(2) and OAR 584, Division 020, the Commission will deny, revoke or deny the right to apply for a license or charter school registration to any applicant or educator who, has been convicted of any of the crimes listed in ORS 342.143, or the substantial equivalent of any of those crimes if convicted in another jurisdiction or convicted of attempt to commit such crimes as defined in 161.405.

1	The Commission's authority to impose discipline in this matter is based upon ORS
2	342.175.
3	FINAL ORDER
4	The Commission hereby permanently revokes Sturgess' teaching license.
