### LAST DAY AND TIME TO OFFER COMMENT TO AGENCY: 12/18/2025 10:30 AM

The Agency requests public comment on whether other options should be considered for achieving the rule's substantive goals while reducing negative economic impact of the rule on business.

A public rulemaking hearing may be requested in writing by 10 or more people, or by a group with 10 or more members, within 21 days following the publication of the Notice of Proposed Rulemaking in the Oregon Bulletin or 28 days from the date the Notice was sent to people on the agency mailing list, whichever is later. If sufficient hearing requests are received, the notice of the date and time of the rulemaking hearing must be published in the Oregon Bulletin at least 14 days before the hearing.

#### **NEED FOR THE RULE(S)**

The Workers' Compensation Board needs to amend its procedural rules related to rulemaking, OAR 438-022-0005 (Adoption of Attorney General's Model Rules) and OAR 438-022-0010 (Notice of Rulemaking), to allow notice of rulemaking to be provided electronically, to make the rules consistent with statute, and to increase accessibility to the Board's rulemaking actions.

ORS 183.341(2) requires state agencies to adopt rules of procedure for rulemaking actions. OAR 438-022-0005 adopts by reference the Attorney General's Model Rules for Rulemaking, but does not inform the reader where to find the model rules. The Board proposes to add a note directing the reader where to find the model rules. In addition, changes are proposed to clarify language and enhance readability.

ORS 183.335(1)(a) and 183.341(4) require state agencies to adopt in rule the manner in which interested persons will be notified of the agency's proposed rulemaking actions. OAR 438-022-0010 provides that interested parties will be notified of the Board's proposed rulemaking actions by mail. ORS 183.335(8), however, allows any person to request rulemaking notice by electronic mail, and ORS 183.335(1)(d) requires rulemaking notice be delivered to certain legislators by electronic mail. The Board proposes to amend the rule to allow notice to be provided by email, consistent with statute.

The proposed rule amendments are intended to increase the public's ability to access the Board's rulemaking actions and apply to any interested person or organization.

#### FISCAL AND ECONOMIC IMPACT:

The proposed rule amendments are expected to have a small positive fiscal or economic impact on other state agencies, units of local government, and members of the public by reducing the amount of physical mail processing. The proposed rule amendments will have a positive effect on the Board through reduced mailing costs.

- (2)(b) The amended rules will require no additional activities or costs to comply.
- (2)(c) It is estimated that the amended rules will not require professional services, equipment, supplies, labor, or increased administration to comply with the rules.

The Board invites public comment on any fiscal or economic impact of the proposed rule amendments.

Notice of Rulemaking ¶

- (1) Prior to adoption, amendment or repeal of any administrative rule, other than a temporary rule adopted under ORS 183.335(5), the Board shall give notice of the intended action: ¶
- (a) In the Secretary of State's Bulletin referred to in ORS 183.360 at least 21 days before the effective date of the intended action:¶
- (b) By mailing <u>or emailing</u> a copy of the notice to persons on the Board's mailing list established pursuant to ORS 183.335(8) at least 28 days before the effective date of the intended action; ¶
- (c) By emailing a copy of the notice to the legislators specified in ORS 183.335(15) at least 49 days before the effective date of the intended action; and  $\P$
- (d) By mailing, emailing, or furnishing a copy of the notice to: ¶
- (A) The Oregonian; ¶
- (B) The Associated Press; and ¶
- (C) The Capitol Press Room. ¶
- (2) The Board shall give notice of any administrative rulemaking hearing: ¶
- (a) In the Secretary of State's Bulletin referred to in ORS 183.360 at least 14 days before the hearing; and ¶
- (b) By mailing <u>or emailing</u> notice of the hearing to any person requesting the hearing and to the persons on the Board's mailing list established pursuant to ORS 183.335(8) at least 21 days before the hearing.¶
- (3) A person or organization may elect to receive notification by mail, email, or both, of the Board's proposed rulemaking actions.¶
