	Code 0124: Ecosystem Restoration- Includes the restoration of ecosystems,	
	natural habitats, natural growth areas, watersheds, riparian areas, wetlands,	
	streams, and aquatic environments. Such work may include the planting of	
	trees, shrubs, and natural grasses, the clearing of brush and weeds, and the	
	removal or placement of soil and rocks. Such work may be accomplished	
	manually or with mechanical equipment. Maintenance of these areas is also	
	contemplated under class 0124.	
	Code 0042: Oregon—Reforestation—Grass Planting & Drivers; applicable to	
	landscape contractors that plant grass in reforested areas by hand or hydro	
	mulch or similar method. All other methods of grass planting in reforested	
	areas are classified to Code 0124. Restoration of ecosystems, natural	

habitats, natural growth areas, watersheds, riparian areas, wetlands,	
streams, and aquatic environments is separately rated to Code 0124.
