## Update on the Consolidate Permit Application/Next Steps

- DOGAMI Dayne Doucet:
  - Comments are slowly being resolved.
  - Goal for the Preliminarily Not resolved category is to be reclassified as resolved, preliminarily resolved, or not resolved.
  - All Baseline Data Reports (BDR) have been accepted as complete, but the CPA is <u>not</u> complete.
  - Stantec is working on the Environmental Evaluation.
  - There are 98 comments remaining that need to be resolved in order to re-evaluate the CPA for completeness. At that point, DOGAMI would issue a Notice to Proceed (NTP).

### Stantec presentation: Environmental Evaluation (EE) Scope and Outline

- The EE will be similar to the Bureau of Land Management's (BLM) Environmental Impact Statement (EIS).
- Chapter 1 contains an introduction to the proposed project, structure and content of the EE, and description of the role of the EE in the consolidated permitting process.

- Chapter 2 contains a project description and alternatives.
- Chapter 3 contains an impact analysis.
  - This analysis will analyze environmental resources that mirror the resources in the BLM's EIS.
  - The socioeconomic and environmental justice portions will be evaluated on another document.
- Open discussion on chapter 4: cumulative impact analysis
  - Difficult to analyze impact of future mines as we don't have any data or consolidated permit applications for these future mines.
- Chapter 5 contains a discussion of mitigation measures existing mines
  - Will mirror BLM's EIS.
- Chapter 6 will list references.
- Appendix A will review cyanide chemistry.
- Appendix B will contain an analysis of credible accidents.
- Appendix C will contain an acid rock drainage assessment and analysis.
- Appendix D will be a review of best available, practicable and necessary technology.
- Randy Jones (DEQ):
  - Will the socioeconomic impact analysis (SEIA) and environmental justice analysis (EJA) be done concurrently with the EE and will the TRT review and approve those outlines?
    - Cameron Curtis (Stantec) the SEIA/EJA will be developed with the EE, and Stantec will collaborate with DOGAMI and TRT agencies on that outline.
  - What standards will Stantec use to develop Appendix C?
    - Cameron Curtis (Stantec) the applicant's monitoring plan will be compared to other mine's plans around the country.
    - Bob Brinkmann (DOGAMI) Stantec will also use the vast amount of data collected by the applicant, the applicant's consultants, and the approved geochemistry baseline data report.
- Bob Brinkmann made the motion to approve the current scope of the EE.
  - Randy Jones seconded the motion to approve.
- Discussion
  - Randy Jones (DEQ):
    - Will there be more TRT meetings as the EE is developed (to support developing the EE)?
      - DOGAMI:Yes.
      - Stantec: plan is to share the info with DOGAMI and TRT as it is developed.
  - Tom Segal (ODFW):
    - Haven't had time to review. If there are issues discovered, do we have the opportunity to change the content in the future?
      - DOGAMI: Yes
- Dayne Doucet (DOGAMI):
  - Call for vote on motion, scope of EE is unanimously approved.

- DOGAMI will post the meeting summary on the project website.
