Draft list of proposed course selections for 2024 Common Course Numbering (CCN) alignment

The following courses were selected from the list of the [80 Most Transferred Courses in Oregon](#) and the [Transfer Council's List of CCN Courses](#). Courses for alignment may include some but not all of the following:

- *Psychology: Lifespan Development
- Biology: 211, 212, 213 or 221, 222, 223
- Economics: 201, 202
- Sociology: 204, 205, 206
- Chemistry: 104, 105, 106 (These courses were listed on the Transfer Council List of Courses; however, CHEM 221, 222, and 223 are much higher on the list of most transferred courses.)
- *Business 131, 212, 226

Course lists with an asterisk represent CCN Subcommittees that convened in 2023 to align other courses. These disciplines are suggested because the groups met in 2023 and have already completed alignment work. Additionally, groups meet for a period of two years (as per the [CCN Faculty Charge](#)). Holding select groups over for additional work takes advantage of the opportunity to extend alignment work to additional classes on the list of the 80 most transferred courses in Oregon.
