Adams, Barbara – Unlicensed

Engaged in unlicensed practice, unethical advertising of services including illegal use of the title, "Licensed Professional Counselor".

<u>Discipline</u>: Payment of civil penalty and disciplinary costs.

04/18/2018

Adams, Meredith - Licensed: C4338

Respondent failed to disclose an arrest on application. She submitted a deceptive narrative to the Board and provided a misleading explanation when questioned by the Board's investigators.

<u>Discipline</u>: Reprimand, practice under supervision, and payment of civil penalty and disciplinary costs.

04/12/2023

Ahana, Dennis – Registered Associate License: R8167

Registrant failed to renew his license, which then expired. Registrant engaged in the practice of professional counseling without being a licensee or associate registered with the Board during September and October 2022.

<u>Discipline</u>: payment of civil penalty and disciplinary costs.

10/12/2012

Alexander, Christa (Bailey) - Licensed: C3369

Licensee provided counseling services to client after her objectivity and effectiveness became impaired; failed to safeguard client confidences.

<u>Discipline</u>: 300 hours of additional supervised intern hours, mental health evaluation, and payment of disciplinary costs.

06/07/2019

Allen, Christopher M. – LPC Application Denied

Engaged in a sexual relationship with a client while licensed as a psychologist in the State of Oregon. Psychology Board imposed discipline.

<u>Discipline</u>: License application denied, payment of disciplinary costs.

10/21/2019

Alvarez, Guillermo J. – License Revoked: T1327

Respondent surrendered his LMFT license in California due to allegations of sexualized misconduct in regard to three minor children who were his clients.

<u>Discipline</u>: License revoked and payment of disciplinary process costs.

04/12/2023

Anderson, Michelle - Registered Associate License: R8136

Registrant failed to renew her license, which then expired. Registrant engaged in the practice of professional counseling without being a licensee or associate of the Board from June 2, 2022 through December 7, 2022.

Discipline: payment of civil penalty and disciplinary costs.

06/04/2021

Anderson, Robert B. – Licensed: C1855

Licensee sent a series of text messages to Client A and Client B that were not welcome, were chiding in tone and content and could be anticipated to cause emotional distress to the recipients.

<u>Discipline</u>: Reprimand, minimum 6-months supervision, additional continuing education and payment of disciplinary costs.

12/06/2022

Aragon, Andrea R. – Licensed: C4638

Licensee failed to create case notes for numerous clients which were necessary to render professional services to those clients.

<u>Discipline</u>: Minimum 3-months supervision, additional continuing education and payment of disciplinary costs.

12/07/2023

Archuleta-Fuller (Barnhurst), Angela – Registered Associate License: R6052 Registrant had a romantic relationship with a family member of a former client within less than five years after her last professional contact with Client.

<u>Discipline</u>: Registration suspended for 6 months, minimum 12 months supervision, additional continuing education and payment of disciplinary costs.

12/07/2021

Arcudi, Joseph A. – Licensed: C5362

Licensee inadvertently shared a webpage containing pornographic images with a client during a telehealth session.

<u>Discipline</u>: Reprimand, \$500 civil penalty, and payment of disciplinary costs.

12/16/2013

Armstrong, Todd - Licensed: C1439

Licensee failed to recognize professional responsibility; failed to avoid client harm by failure to immediately report suspected child abuse; failed to provide counseling records; failed to refer client when personal situation was interfering with ability to provide professional services.

<u>Discipline</u>: Supervision for 6 months, additional ethics course, child abuse reporting requirements course, and payment of disciplinary process costs.

02/01/2019

Baker, Samuel C. - Licensed: C1833

Licensee provided client information in a request for referral on social media without obtaining client consent.

<u>Discipline</u>: Reprimand, additional continuing education and payment of disciplinary costs.

03/08/2013

Baldwin, Heidi – Intern Registration Revoked: R1853

Respondent engaged in an inappropriate dual and sexual relationship with a client. <u>Discipline</u>: Internship revoked; permanently prohibited from seeking licensure or internship or using any like title.

04/20/2024

Barshaw, Lacey K. – Registered Associate License: R7920

Registrant failed to keep accurate records of client appointments and cancellations resulting in approximately five instances where Registrant's clients were improperly charged for "no show" fees.

<u>Discipline</u>: continuing education and payment of disciplinary costs.

10/13/2017

Bartholomew, Stacey - License Surrendered: C3291

Engaged in an inappropriate dual and sexual relationship with a client.

<u>Discipline</u>: Surrender of license, payment of disciplinary costs.

08/08/2023

Baska, Richard - Unlicensed

Engaged in the practice of professional counseling or marriage and family therapy without being a licensee or associate registered with the Board.

<u>Discipline</u>: \$2,500 civil penalty (stayed) and disciplinary costs.

02/13/2023

Beachler, Terri – LPC: C4676

Licensee continued to engage in a power struggle with Client A when he was becoming increasingly dysregulated, thereby escalating his dysregulations and distress, which could be reasonably expected to cause Client A immediate emotional harm.

<u>Discipline</u>: minimum 18-months supervision, additional continuing education and payment of disciplinary costs.

12/02/2016

Becker, Alvin - LPC Intern Application Denied

Respondent submitted an application that was deceptive to the Board. Respondent misrepresented an arrest that occurred in 2010. The Board investigation revealed respondent was arrested and convicted of ORS 163.575.

<u>Discipline</u>: Application is denied and payment of disciplinary costs.

12/11/2020

Becker, Marla J. - License Surrendered: T0487

Licensee blurred her roles as a therapist and a yoga teacher. Client A, an adult male began attending Licensee's yoga classes in the autumn of 2017. Client A began meeting with licensee for marriage counseling in March of 2018. In June of 2018, Licensee began a sexually intimate relationship with Client A that continued into 2019. <u>Discipline</u>: License surrendered and payment of disciplinary costs.

07/16/2014

Becsei, Aniko – Licensed: C1402

Licensee dispensed prescription medication; practiced outside boundaries of competence.

<u>Discipline</u>: Written reprimand.

04/20/2024

Bennett, Minette. - Licensed: C5716

Licensee entered into a non-professional relationship with Client which had the potential to be harmful to Client because she was put in a position where she was likely to become personally, emotionally and financially dependent on Licensee and where she was potentially exposed to unwanted physical contact by Licensee's family member. Licensee did not consult with other counselors or professionals.

<u>Discipline</u>: Minimum 12 months of supervision, continuing education and payment of disciplinary costs.

12/11/2020

Benson, Charles H. – License Revoked: T1587

Licensee self-reported that the California Board of Behavioral Sciences had disciplined his license due to unprofessional conduct, gross negligence, failure to maintain confidentiality and causing physical or emotional harm to a client. Licensee failed to disclose the complaint on his application for licensure with this Board.

<u>Discipline</u>: License revoked and payment of disciplinary costs.

09/05/2019

Berlingen, Linda – Licensed: C2120

Licensee was providing counseling to a minor child (with a history of domestic/sexual abuse from her father) to address her panic attacks and trauma. Upon seeing a picture of the father, Licensee told the minor client that the father was handsome. Licensee further told the minor client and her mother (persons of color) that they looked alike. Discipline: Six months supervision, continuing education and payment of disciplinary costs.

12/02/2016

Bertoli, Jeanne – Unlicensed

Individual engaged in illegal unlicensed practice of professional counseling via Skype. <u>Discipline</u>: \$2,500 civil penalty and payment of disciplinary costs.

10/2/2021

Bilyeu, Jeff J. – Licensed: C6311

Unlicensed practice by engaging in the practice of professional counseling and using the title "Licensed Professional Counselor" after his license expired.

<u>Discipline</u>: Reprimand, \$1,000 civil penalty, additional continuing education, and payment of disciplinary costs.

04/02/2010

Bird, David - License Revoked: T0375

Engaged in dual relationships with multiple clients; used the counseling relationship to further sexual interests; engaged in or solicited a sexual relationship with client; used the counseling relationship to further his personal and financial interests; negligence; failed to conform to standards of conduct; failed to recognize professional responsibility and caused harm to clients; breach of confidentiality.

<u>Discipline:</u> License revoked; forever prohibited from holding a LPC or LMFT license in Oregon; payment of disciplinary costs.

07/16/2014

Blaszak, Barbara – License Surrendered: C0083 and T0038

Failed to provide the mother of two minor children with a copy of the children's counseling records because she had lost them.

<u>Discipline</u>: Licensee surrenders both Oregon LPC and LMFT licenses, and prohibited from using the title, purporting to be, or practicing as a LPC or LMFT or using any other title that includes those words in the state of Oregon.

08/08/2023

Blaszczak, Sarah – Licensed: T1554

Licensee engaged in email and text communications with a client outside of therapy sessions knowing that the client's behavioral health conditions called for containment and boundary setting in the relationship with a therapist.

<u>Discipline</u>: Minimum 6 months of supervision, continuing education, and payment of the disciplinary costs.

06/18/2008

Bliss, Vivien – Licensed: C1117

Licensee exceeded the scope of her license by reviewing and testifying in court regarding test scores for program participants.

Discipline: Written reprimand, civil penalty and payment of disciplinary costs.

04/05/2019

Bogan, Christine K. - Unlicensed

Individual provided false information on her LPC application, failing to truthfully attest to the circumstances of her arrest and conviction of a crime. She failed to cooperate with the subsequent Board investigation.

<u>Discipline</u>: Denial of licensure and payment of disciplinary costs.

12/07/2023

Bolles, Sharon, E. - Licensed: C7522

Licensee failed to renew her license, which then expired. Licensee engaged in the practice of professional counseling without being a licensee of the Board for the period of approximately January 2023 through June 2023.

<u>Discipline</u>: payment of civil penalty and disciplinary costs.

02/03/2017

Bond-Frojen, Searainya – Licensed: C2989

Licensee engaged in boundary violations, sending personal photos and sexualized communication with inmates and former inmates of various DOC facilities.

<u>Discipline</u>: License surrendered under investigation. May not reapply for two years and must obtain a psychosexual evaluation. Payment of disciplinary costs.

04/29/2013

Boudinot, Douglas - Unlicensed

Individual engaged in illegal unlicensed practice.

Discipline: Civil penalty of \$5,000, to be suspended under the condition the

Respondent abides by Stipulated Final order, however must pay of disciplinary costs.

12/07/2018

Boudinot, Douglas - Unlicensed

Engaged in unlicensed practice in violation of his previous Stipulated Order.

Discipline: \$5,000.00 civil penalty.

08/13/2010

Bourcy, Lyle – Renewal Denied: C2200

Disciplinary action by Idaho State Board found Licensee engaged in an inappropriate sexual affair with a Client's mother. Idaho Board found Licensee's conduct violated Idaho laws and rules; Licensee surrendered Idaho License.

<u>Discipline</u>: Renewal of his Oregon license is hereby denied and payment of disciplinary costs.

06/06/2014

Boyce, Mary J - Licensed: C3694

As an Intern, failed to safeguard confidential client files; left records unattended in her vehicle, then failed to immediately take action to locate records.

<u>Discipline</u>: Supervision for six months, one session per month, with report to Board.

07/17/2012

Bramlette, Susan - Licensed: T0456

Provided therapy to client without written consent to treat and disclosed confidential information without consent while practicing in Washington State.

<u>Discipline</u>: Supervision for two years, 18 additional hours of continuing education, payment of disciplinary costs.

03/05/2009

Bramlette, Susan - Licensed: T0456

Arizona Board action which indicates violation of Arizona law.

<u>Discipline</u>: Complete one graduate-level ethics course with a grade of "B" or higher and one year of supervision.

08/08/2023

Branch, Matthew – Applicant

Applicant affirmatively made a full disclosure to the Board regarding his prior criminal history. Applicant pled "no contest" to one felony count of encouraging child sex abuse in the second degree. After successful completion of all terms of probation, the Court reduced Applicant's conviction to a misdemeanor. The Board has authority to deny Applicant's application pursuant to ORS 675.745(1)(j). Applicant was assessed as "low" or "very low" for the risk of future criminal conduct.

<u>Discipline</u>: Prohibition from working with any client under the age of 18 years of age and costs.

12/13/2019

Briggs, James J. - License Suspended: C4959

Respondent's client was concerned about paying for sessions taken with Respondent required by a court. The Respondent bartered with client while holding a position of power over the client and failing to make records of the arrangement in the chart notes. <u>Discipline</u>: License suspended for six months with four months stayed, practice under supervision, meet with a health care professional for 24 sessions, complete 12 hours of continuing education and pay costs of the disciplinary process.

04/12/2023

Brunelle, Jessica - Licensed: C4310

Licensee recycled notes from prior sessions which contained outdated information making the records incomplete, inaccurate, or otherwise inadequate.

<u>Discipline</u>: Minimum 6 months supervision, 6 additional continuing education, and payment of disciplinary costs.

08/13/2010

Brunning, Vincent – Previously licensed: C1086

Failed to recognize professional responsibility and caused harm to clients and coworkers; failed to conform to standards of conduct; treated clients and coworkers in a discourteous and disrespectful manner.

<u>Discipline</u>: Written reprimand; supervision for one year, six hours training in suicide assessment and intervention, three hours training in social and cultural competency and diversity, and payment of disciplinary costs.

06/05/2018

Bruton, Wendy – License Surrendered: C2439

Entered into a multiple relationship with her interns. Failed to provide appropriate supervision to interns. Failed to inform the Board in a timely manner when business location was moved.

Discipline: Surrender of license, payment of civil penalty and disciplinary costs.

10/07/2016

Buchanan, Danette – Licensed: C3577

Client of Respondent disclosed that she had a felony conviction and had been incarcerated. Respondent subsequently submitted a public records request to Oregon State Police seeking a copy of client's criminal offender information. Client incurred harm. Respondent failed to take care to do no harm to client.

Discipline: Written reprimand, and payment of disciplinary costs.

12/01/2017

Buck, Andrew W. -Intern Registration Revoked: R4556

Breached client confidentiality. Failed to disclose termination from previous employment. Repeatedly counseled about lack of professional demeanor and subsequently terminated from employment.

Discipline: Revocation of registration, payment of disciplinary costs.

04/09/2020

Buckwalter, Angela N. - LMFT Intern Registration Suspended: R4671

Registrant failed to take steps to ensure consistency in supervision throughout her internship. Failed to promote the welfare of a client and to avoid harm by moving client out of their foster care home facility and then abandoning the client.

<u>Discipline</u>: Suspension of registration and payment of disciplinary costs.

12/01/2017

Bullock, Mark - License Surrendered: C4410

Licensee failed to disclose that he had been under investigation by a former employer when he submitted an application for licensure by reciprocity. The Board concluded Licensee made numerous repeated sexual advances toward female employees in the workplace.

<u>Discipline</u>: Surrender of license, payment of disciplinary costs.

08/14/2018

Bush, Alison L. – LPC Intern: R3710

Registrant's employment record noted excessive absences due to health related issues that interfered with her ability to practice. Registrant was cited for driving under the influence of an intoxicant and ordered into diversion.

<u>Discipline</u>: Registrant was reprimanded and ordered to pay disciplinary process costs.

12/07/2023

Byloos, Matthew C. – Registered Associate License: R7437

Registrant listed his credentials inaccurately when he publicly described himself as a Licensed Professional Counselor when he was not.

<u>Discipline</u>: Reprimand, ordered to pay a civil penalty and the costs of disciplinary process.

02/13/2023

Byrem, Catherine – Registered Associate License Revoked: R4630

Registrant did not respect Client A's dignity or promote their welfare and failed to record key information known to Registrant in a written suicide risk assessment. Registrant engaged in a personal friendship with Client C outside of the counseling relationship. Registrant engaged in a sexual or romantic relationship with Client E. Registrant made omissions and misleading statements to the Board investigator.

<u>Discipline</u>: Registration revoked, ordered to pay a civil penalty and the costs of disciplinary process.

06/07/2019

Cable, Lindsay A. - Licensed: C2866

Licensee disclosed confidential client information to a third party without the proper release of information.

<u>Discipline</u>: Reprimand, continuing education, payment of disciplinary costs.

08/11/2023

Cader, Gale - Licensed: C5337

Licensee provided associate supervision to three registrants. Licensee failed to incorporate into her supervision the principles of informed consent, did not take steps to monitor the registrant's compliance with the ACA Code of Ethics, and failed to notify the Board of the termination of her associateship supervision.

<u>Discipline</u>: Prohibition from supervising registered associates for a minimum of 1 year and up to 3 years, payment of civil penalty and disciplinary costs.

02/13/2023

Carlile, Viola – Licensed: C6333

Engaged in the practice of professional counseling after her license expired for the period of approximately July 2020 through August 2021.

Discipline: payment of civil penalty and disciplinary costs.

04/12/2023

Carroll, Kari – Licenses Expired: C5232, T1534

Licensee did not protect the confidential information of her client - the client's status as a client - and effectively disclosed it without appropriate consent.

<u>Discipline</u>: Reprimand, 6 additional continuing education hours, payment of civil penalty and disciplinary costs.

06/07/2022

Casado-Perez, Javier F. – Licensed: C5360

Licensee engaged in a romantic and sexual relationship with a student in a program that Licensee was the co-coordinator of.

<u>Discipline</u>: Reprimand, \$1500 civil penalty, two specific CE courses, payment of disciplinary costs.

06/07/2016

Chapman, Terri - Licensed: C1386

Respondent was impaired and unable to safely practice; failed to self-report extensive impairment history.

<u>Discipline</u>: Immediately withdraw from practice, complete treatment and fitness for duty evaluation.

12/13/2019

Castle, Summer L. - Intern Application Denied

While working as a volunteer marriage and family therapist under supervision, Respondent entered into a therapeutic relationship with a client and the client's partner. Later, Respondent sent Facebook messages to the client, voicing her attraction to both the client and client's partner. Respondent also stated that she fantasized about client, was flirty and had no sexual filter.

<u>Discipline</u>: Intern application is denied and payment of disciplinary costs.

10/14/2011

Clark, James R – Licensed: C1913

Failed to refer clients to other treatment resources when warranted and provided services to clients beyond his area of practice.

<u>Discipline</u>: 6 months of supervision and report to the Board, a written reprimand and payment of disciplinary costs.

08/10/2020

Clarke Pelton, Kathleen – Licensed: C5572

Licensee failed to renew her license and engaged in unlicensed practice for a period of two months in 2019.

Discipline: \$250 civil penalty.

10/04/2019

Cleaver, Christopher – License Surrendered: C3414

Licensee was providing supervision to an intern. Licensee engaged in a personal relationship with the intern that led to a sexual relationship

Discipline: License surrender, civil penalty, and payment of disciplinary costs.

12/10/2010

Coats, Diana Lynn - Licensed: C2554

Provided supervisor with prescription medication; failed to report supervisor to health licensing board and agency management in a timely manner.

Discipline: Additional intern supervision with report, payment of disciplinary costs.

04/12/2023

Coffey, Karlee – Registered Associate License: R7066

Registrant did not adequately consider the risks of extending the counseling relationships with Client A beyond the conventions of therapy. Registrant did not document the rationale for the extension prior to the boundary extension with Client A. <u>Discipline</u>: Minimum 6 months supervision, 3 additional continuing education hours, and payment of disciplinary costs.

09/04/2014

Collier, Anna N. – Licensed: C3000

In the course of her employment by the Health Professional Service Program, Licensee compromised the confidentiality of clients when sending out a group email.

<u>Discipline</u>: Written Letter of Reprimand, ethics course, and payment of disciplinary costs.

12/13/2013

Cook, Jeffrey – Licensed: C2353

Inappropriate and improper communications with client over a period of three years, in person and later by telephone, violated confidentiality of client in communications with client's husband, failed to terminate counseling relationship despite admission that he was unable to help client.

<u>Discipline</u>: Supervision for six months with report, ethics course, payment of disciplinary costs.

06/08/2023

Coren, Rebecca R. – Licensed: C7231

Licensee failed to renew her license, which then expired. Licensee engaged in the practice of professional counseling without being a licensee of the Board for the period of approximately September 30, 2022 to January 16, 2023.

Discipline: payment of civil penalty and disciplinary costs.

06/04/2021

Cox, Courtney H. – Registration Suspended: R6017

Registrant encouraged a client to engage in illegal conduct by consuming a Schedule I substance that could expose a former client to physical harm and legal consequences. Registrant entered into a non-professional relationship with a former client failed to practice only within the boundaries of her competence, training and supervised experience.

<u>Discipline</u>: Registration revocation stayed pending successful completion of supervision and probationary periods; registration suspended for two years during which time Registrant shall undergo monthly therapy, supervision additional continuing education and write formal apologies; following completion of suspension Registrant shall serve a further five-year period of probation with an additional 500 hours of supervised practice and costs of the disciplinary process.

06/06/2014

Creason, Traci L. - Licensed: C2926

Licensee confided personal romantic feelings for an inmate client and opened a PO Box so the inmate could write to her, also failed to transfer client to another counselor. Discipline: One year supervision, with report, Board-approved ethics course on dual relationships, payment of disciplinary costs.

08/08/2023

Cripe, Florence - Licensed: T7300

Licensee failed to renew her license, which then expired. Licensee engaged in the practice of professional counseling without being a licensee of the Board for the period of approximately July 2, 2022 through January 3, 2023.

<u>Discipline</u>: payment of civil penalty and disciplinary costs.

08/04/2008

Crippen, John – Licensed: T0692

Failed to respect the rights of his client by allowing his religious perspectives and views to affect the counseling relationship.

Discipline: Written reprimand, submit revised Professional Disclosure Statement.

02/05/2016

Cudmore (Trotter), Rachel - Licensed: C2027

Licensee's conduct reflects that she failed to consider impact of her personal conduct in regard to Client A, and how her conduct could be harmful and exploitive in regard to both Client A and B.

<u>Discipline</u>: Licensee is reprimanded, 1 year of supervision, payment of disciplinary costs.

Darien, Jay – Licensed: T1460

Practiced outside the scope of competency by testifying in a custodial dispute when Licensee was not trained to conduct custody evaluations. Licensee failed to clarify for the Court that Licensee was not qualified to provide testimony regarding the mental state of the client's Father about the client's best interest.

<u>Discipline</u>: additional continuing education and payment of disciplinary costs.

06/09/2017

Davis, Christina L. - Licensed: R5038

Accessed confidential client file for personal reasons.

<u>Discipline</u>: Reprimand, complete an ethics course, supervision until granted unrestricted license, payment of disciplinary costs.

11/01/2012

Davis, Jeffrey S. - LPC Application Denied

Engaged in a sexual relationship with former client while licensed in the State of New Mexico. NM Board imposed discipline, as Respondent did not contest the allegations. Discipline: License application denied and payment of disciplinary costs.

07/12/2012

Delaney, James – Licensed: T0899

Failed to report suspected child abuse after being told by second party first and then verified by victim.

Discipline: Ethics class, supervision, disciplinary costs.

10/11/2023

Dempsey, Keith - Licensed: C7139

Licensee failed to renew his license, which then expired. Licensee engaged in the practice of professional counseling without being a licensee of the Board for the period of approximately August 2022 through November 2022.

Discipline: payment of civil penalty and disciplinary costs.

12/07/2023

Devine, Deborah L. - Licensed: T2382

Licensee failed to renew her license, which then expired. Licensee engaged in the practice of marriage and family therapy without being a licensee of the Board for the period of approximately December 1, 2022 through July 10, 2023.

<u>Discipline</u>: payment of civil penalty and disciplinary costs.

04/02/2021

Dietzschold, Dica M. - Unlicensed

Individual engaged in unlicensed practice.

Discipline: \$1,000 civil penalty and costs of the disciplinary process.

08/08/2023

Dimitras, Carmen – Registration Suspended: R6666

Failed to cooperate with a Board investigation.

<u>Discipline</u>: 3 months suspension or until cooperation with the Board's investigation and costs of the disciplinary process.

09/22/2009

Dody, Nadine – Licensed: C1979

Engaged in a dual relationship with client; failed to advance client's best interests; failed to act in accordance with highest standards of professional integrity and competence. <u>Discipline</u>: Written reprimand; supervision for one year; payment of disciplinary costs; six hours ethics training; ACCBO accredited A&D counseling theories training.

05/16/2014

Donaldson, Steven M. - Licensed: C0975
