SUMMARY OF PREVIOUS BOARD ACTION/ CHANGES SINCE LAST BOARD MEETING?

- The State Board of Education received a first reading in June of 2015. At this meeting, the board discussed abstentions. The board decided to strike out suggested language that would not allow board members to abstain.
- The State Board went into recess. Since September of 2015, the meeting agendas were full to hear new edits.
- The changes are being brought back as a first reading in order to allow board members time to review edits and suggested language.

POLICY ISSUE OR CONCERNS

- The board will have three vacancies by the end of June. This raises quorum concerns. If there are only four board members present out of a seven member board, all four board members must be present to vote. Additionally, all four board members must vote in favor of the motion in order to it be approved.
- In the absence of quorum, the board can only meet for the purposes of information gathering. If one board member misses a board meeting, the consent agenda and action items cannot be approved.
