ISSUE BEFORE THE BOARD: Bend-LaPine School District as submitted a revised supplemental plan for approval

BACKGROUND: ORS 327.006 includes supplemental plans approved by the State Board of Education as part of "Approved Transportation Costs". Also, ORS 327.043 requires districts to provide transportation to students identified in a supplemental plan approved by the State Board of Education.

Bend-LaPine School District's original supplemental plan was approved in 1992 and updated in 2001, 2003, 2005 and 2010.

This new plan will amend the current plan and update for changes in the district since 2010, including changing attendance boundaries and new schools.
