### **ISSUE BEFORE THE BOARD**:

Approval for the assets from closing LEP Charter School in PPS to be disbursed to PPS first and then other charter schools in the State of Oregon.

## **BACKGROUND:**

According to ORS 338.105, if a charter is terminated or a public charter school is dissolved, the assets of the public charter school that were purchased with public funds shall be given to the State Board of Education. The State Board of Education may disburse the assets of the public charter school to school districts or other public charter schools. However, according to Education Department General Administrative Regulations (EDGAR), any assets purchased with the federal grants must be distributed to other like federal grant sites, which would be charter schools. The Oregon Department of Education (ODE) received a list of all LEP Charter School assets purchased with public funds and will ensure distribution according to the fund source.

LEP Charter School has provided a list of assets purchased with the federal Charter School Program grant funds as the only physical assets of the public charter school. These assets must be made available to public charter schools.

ODE has a process to distribute the assets to other Oregon charter schools.

## **STAFF RECOMMENDATION:**

The Deputy Superintendent and ODE staff recommend approval of the disbursement of assets first to public charter schools sponsored by PPS, then to PPS, and then to other Oregon public charter schools.

Ms. Pattison -

Portland Public Schools is the sponsor of Leadership and Entrepreneurship Public Charter High School (LEP), which will close at the end of the 2014-15 school year. After closure, LEP's assets will be distributed according to ORS 338.105(6)(a). To that end, we would like to request the following:

- Portland Public Schools (PPS) would like first right of refusal for any and all technology equipment that will be distributed.
- PPS is currently ensuring that LEP can remain open for the remainder of the 2014-15 school year in part by
  funding whatever discrepancy that exists between LEP's payroll expenses and its State School Fund allocation.
  We project that, by the end of the school year, we will have given LEP approximately \$200,000 in additional
  funding to cover payroll expenditures. We request that, should any residual funds be remaining after LEP's final
  payroll is paid, these funds be returned to PPS.

# Re: KOREducators #33720 Transfer of Assets of Leadership and Entrepreneurship Public Charter High School

Greetings:

KOREducators, a nonprofit public benefit corporation, operates the Leadership and Entrepreneurship Public Charter High School (known as "LEP") based on a contract entered into with the Portland Public School District. Portland Public School District and KOREducators have agreed to close LEP at the end of this school year and terminate the charter agreement between them.

Oregon Revised Statute 338.105(6) requires public charter schools to give all assets that were purchased with public funds to the State Board of Education when a charter agreement is terminated. The State Board of Education then distributes assets to other charter schools or school districts. The State Board of Education through its designee, the Department of Education, has agreed with KOREducators for this transference of assets to occur on June 26, 2015. Charter schools and Portland Public School District will be notified of the date and location to pick-up property.

KOREducators recognizes that your office has jurisdiction over the transference of assets of a public benefit corporation when this transfer is substantially all of its property, and it is not in the usual or regular course of its activities. (ORS 65.534(7)). In this situation, the public benefit corporation is required to give your office 20 days notice.

KOREducators has other assets, but the assets for LEP purchased with public funds are a majority of its assets. KOREducators requests that this letter be considered the 20-day notice to your office under ORS 65.534(7). KOREducators is in the process of putting together a list of assets to provide to the Oregon Department of Education. We would be glad to submit this list to your office as soon as this is available. KOREducators is collaborating with Portland Public School District in this process of transferring LEP's property.
