ISSUES BEFORE THE BOARD: The State Board of Education expressed a desire to continue operating with a Charter School Subcommittee to hear topics and make recommendations regarding public charter schools. If the State Board is going to continue with a charter school subcommittee, the Board must nominate and approve members of this committee.

BACKGROUND: In May 2013, the State Board of Education approved the formation of the charter school subcommittee to be made of two board members and the superintendent advisor. The subcommittee has heard a number of charter school topics and made recommendations to the full board for decision. It is time for the State Board to nominate subcommittee members and approve them if the State Board would like to continue with the charter school subcommittee.
