**PROPOSED/AMENDED RULE SUMMARY:** Revises the existing rules on STEM Hub grants to align with new requirements in HB 3072 (2015) and creates a new rule specifying what entities can be a fiscal agent for CTE and STEM grants.

#### **BACKGROUND:**

HB 3072 (2015) is the CTE/STEM framework bill. HB 3072 made changes to the existing STEM Hub grants, and those changes required rule changes. In addition, based on experience administering the grant in the 2013-15 biennium, ODE staff determined that additional changes were necessary.

## Definitions / OAR 581-017-0301:

 HB 3072 includes Education Service Districts. It was therefore necessary to add a definition of education service district or ESD.

### Fiscal Agent for CTE and STEM grants / OAR 581-017-0302:

• In the last biennium, when the STEM Hubs were part of the Strategic Initiatives, it was possible for a grant to be awarded to a nonprofit. HB 3072 provides that only the following entities may be fiscal agents for the STEM and CTE grants: school districts, education service districts, public schools, public charter schools, community colleges, and public universities. This rule clearly specifies the fiscal agents that are identified in HB 3072.

### STEM Hub Grants / OAR 581-017-0306 to 0318:

- ESDs and the nine federally recognized Native American Tribes in Oregon are added to the list of possible Hub partners.
- The biggest structural change is in 581-017-0312 and 581-017-0315. In the 2013-15 biennium, the grants were structured as one award that was paid out in phases. Based on experience in the 2013-15 biennium, and a desire to strengthen the administrative support for the STEM Hubs, the grants are now broken into two separate grants one for operations support and one for program support.
- The reporting section, 581-017-0318, was amended to include the legislative report that is required by HB 3072.
