Excerpt from Charter: Responsibility of Members

1. Attend advisory committee meetings. Meetings will be held in-person and/or virtually to allow for full participation of advisory committee members across the state.
2. Share relevant information from represented organizations and experience to the advisory committee.
3. Connect with constituents and local networks to share the work of the advisory committee and share feedback with the advisory committee.
4. Review materials prior to meetings and join meetings prepared to provide informed input.
5. Inform ODE staff if you anticipate missing one or more meetings.
6. Recuse selves or state conflicts of interest when situations arise where a conflict may occur.

Removal from the advisory committee will occur when a member is absent for two (2) consecutive meetings unless prior notice is given to ODE staff.



Request For Application

RFA Timeline and Process

RFA timeline:

- Finalized with Procurement on 4/23
 - Includes scope of work, budget planning document, all components that RSAC worked on & recommended
- Procurement team will review and submit to DOJ (by 4/26?)
- Once DOJ approves - it will be opened for application (by first week in June?)
- When opened - one single point of contact, which is procurement person
 - They will facilitate the pre-application meetings
 - All questions go through procurement

Budget / Funding

Base Level Funding Discussion

Overview of OAR:

The new law provides a unique funding structure to include a high school education experience and to meet graduation requirements, provide special education services, substance use supports and behavioral health services.

- Approved recovery high schools will be funded with sufficient base funding in addition to a per student ADM.
- Funding will be separate from regular school district State School Fund (SSF) grants and will combine some SSF and Statewide Education Initiative Account (SEIA) funds.

What factors should be considered with determining a base level of funding:

- Number of Students
- Location of site
- Building rented or in-kind donation
- Flat amount

Funding Model

State School Funding: (SSF)

\$10,031 ADMw X 2.0 for each student enrolled (6/2023)

Statewide Education Initiatives Act: (SEIA)

\$2,049,768 - one year only - will be renewed in the 25-27 biennium

Based on this information:

- What is a recommended baseline funding amount?
 - How much does a school need for start up?
 - Should the amount be different after the first full year of operation?
 - Do we add components of funding requirements - ie Summer programs?

Contracting for Services

ARS Contract:

Contract with Association for Recovery Schools (ARS) to provide coaching to recovery schools, support for ODE for opening of schools and to write a manual / toolkit for recovery schools.

Potential Contract for Summer Pilot Program:

Potential contract for current recovery programs to provide 4 weeks of summer school.

Parameters:

Credit recovery and recovery supports

At least 3 days per week / 15 hours

In-person



Evaluation of Schools

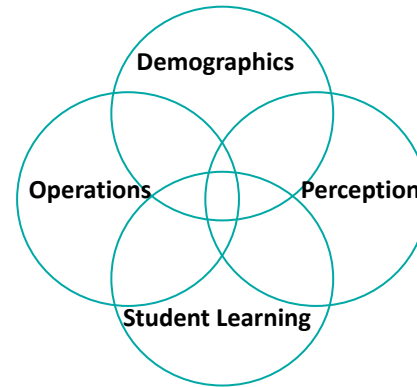
Cycle and Scope of School Evaluations

Meeting schedule & Next Steps

Charter Agreement

The Recovery Schools Advisory Committee will meet at least four times a year and last approximately 3 hours on the 2nd or 3rd Wednesday of the month; additional meetings may be requested. The committee may agree upon an alternate schedule for meetings. Meetings are typically held remotely. The meeting schedule for the year will be set by May 1 of each year for the following school year. When meetings are held in-person, advisory committee members will be reimbursed in accordance with ODE policy for travel expenses related to attending meetings.

ODE will provide interpreters and other necessary services at Recovery Schools Advisory Committee meetings, providing notice of such need is submitted to the Department at least one week before the scheduled meeting.

There will not be proxy attendance for this advisory committee. ODE staff are responsible for following up with advisory committee members who miss a meeting to debrief them on agenda items discussed.
