FINDINGS OF FACT

- (1) On January 6, 2010, Z.T.'s parents, by and through their attorney, requested a due process hearing. The matter was referred to the Office of Administrative Hearings on January 6, 2010, for hearing, and the matter was assigned to Administrative Law Judge (ALJ) Stephen H. Elmore. A pre-hearing teleconference was set for February 10, 2010.
- (2) ALJ Elmore conducted the February 10, 2010, pre-hearing conference. The parents' attorney and the attorney for the District informed ALJ Elmore that a mediation session had been scheduled for April 21, 2010, and requested waiver of the 45-day deadline to allow the parties to work toward resolution. A second pre-hearing conference was set for April 27, 2010.
- (3) ALJ Elmore conducted the April 27, 2010, pre-hearing conference. The parents' attorney and the attorney for the District informed ALJ Elmore that the parties had reached agreement resolving all issues. The parties subsequently executed a written agreement memorializing the resolution of all issues, and on May 13, 2010, the parents' attorney requested that the parents' request for a due-process hearing be dismissed with prejudice. Because no issues remain to be resolved, a contested case proceeding no longer is required.

ORDER

All issues having been resolved, the hearing request of January 6, 2010, is **DISMISSED** with prejudice.
