**FINDINGS OF FACT**

1. On November 30, 2017, Parent filed a request for a due process hearing. On December 1, 2017, the Oregon Department of Education referred the request to the Office of Administrative Hearings (OAH).

2. On January 4, 2018, Senior Administrative Law Judge (ALJ) Alison Greene Webster held a prehearing conference by telephone. The School District participated through counsel, Taylor Richman; Parent participated without counsel. During the conference, the parties advised they had agreed to mediation, and jointly requested waiver of the 45 day hearing timeline pending the mediation session.

3. Via electronic mail on March 1, 2018, Parent advised OAH that the parties had reached a mediated settlement. Parent also advised OAH that she would be formally withdrawing the hearing request upon her receipt of an executed settlement agreement. Via electronic mail on April 17, 2018, Parent formally withdrew the due process hearing request.

**ORDER**

Parent's request for due process hearings in the above-captioned matter is withdrawn. The case is dismissed with prejudice.
