FINDINGS OF FACT

(1) On February 20, 2018, Mother filed a request for due process hearing with the State Superintendent of Public Instruction on behalf of D.J. (Student). The Department of Education referred the hearing request to the Office of Administrative Hearings (OAH). The OAH assigned Administrative Law Judge (ALJ) Jill Marie Messecar to preside over the hearing in this matter.

(2) . On March 23, 2018, Mother notified the OAH via email that the District had stopped the proposed change of location of the Pioneer Program and that Mother believed that the Due Process hearing was not needed. On April 2, 2018, Mother clarified that she wished to withdraw the due process complaint without prejudice

ORDER

The February 20, 2018, request for a due process hearing has been withdrawn and the case is dismissed without prejudice.
