#### I. BACKGROUND

On August 8, 2019, the Oregon Department of Education (Department) received a letter of complaint (Complaint) from the legal counsel for a Parent (Parent) and student (Student) who reside in the McMinnville School District (District). The complainant requested that the Department conduct a special education investigation under Oregon Administrative Rule (OAR) 581-015-2030. The Department provided the District with a copy of the Complaint on August 9, 2019.

On August 13, 2019, the Department sent a *Request for Response* (RFR) to the District identifying the specific allegations in the Complaint to be investigated and establishing a *Response* due date of August 27, 2019. Subsequently, after receiving additional information from the Parent's legal counsel, the Complaint Investigator (Investigator) amended the RFR to more accurately reflect the Parent's allegations. The Amended RFR was sent to the parties on August 22, 2019. On August 23, 2019 the District submitted its *Response* via email and in hard copy via first class mail. The *Response* included a narrative and the following documents:

The Parent was unable to distinguish between documents that had been received from the District on June 25, 2019 from documents that had been received at a later date. Parent's legal counsel stated that the District failed to produce the Student's entire educational record. On September 9, 2019, the Parent provided documents to the Investigator, explaining the following records were received in September 2019:

Thereafter, attorneys for the Parent and District submitted written correspondence regarding the allegations of either party. No other evidentiary documentation was included with either correspondence.

The Department has jurisdiction to resolve this Complaint.<sup>1</sup> Under federal and state law, the Department must investigate written complaints that allege Individuals with Disabilities Education Act (IDEA) violations that occurred within one year prior to the Department's receipt of the complaint. This Complaint covers the one-year period from August 9, 2018 through August 8, 2019. The Department must issue a final order within sixty days of receiving the complaint. This Order is timely.

# II. ALLEGATIONS AND CONCLUSIONS

The Parent's allegations and the Department's conclusions are set out in the chart below. These conclusions are based on the Findings of Fact in Section III and the Discussion in Section IV.

## REQUESTED CORRECTIVE ACTION

- 1. A finding that the District is in violation of the IDEA for failure to provide the requested educational records within 45 days after the request has been made; and
- 2. The District should be compelled to provide the Parent with the Student's educational records.

### III. FINDINGS OF FACT

- 1. The Student is seventeen years old and is eligible for special education services under the categories of Intellectual Disability and Communication Disorder.
- 2. The Student transferred into the District during the 2016-2017 school year.
- 3. The Student has been suspended three times while attending school in the District and demonstrated an increase in non-compliant behaviors during May 2019.
- 4. On or about May 24, 2019, the Parent executed a release so that the Student's educational records could be shared with the Parent's legal counsel. The Parent's legal counsel sent out

a request for the Student's educational records initially via facsimile on May 24, 2019 to the District's legal counsel. Thereafter, the Parent's legal counsel sent a request for educational records to the District via email and by first class mail on May 28, 2019. The Parent's legal counsel received notice that the facsimile to the District had not transmitted and thereafter requested clarification on the facsimile and email communication from the District's legal counsel.

- 5. The District's Special Education Director directed District staff to retrieve the Student's records so that they could be submitted to the Parent. The Special Education Director's secretary was charged with compiling the Student's educational record.
- 6. On June 24, 2019, District sent the Student's educational record to the Parent's legal counsel's office. The records were sent by certified mail, return receipt requested.
- 7. On June 25, 2019 at 11:34 a.m., an employee in the Parent's legal counsel's office signed the postal receipt for the package containing the Student's educational records. The Investigator independently verified delivery through the USPS.com website's tracking feature.
- 8. The Student's educational records that were delivered to the Parent on June 25, 2019 included IEPs, classwork, notes, meeting notes, prior written notices, notices of suspension (discipline), behavioral referrals, memorandum of non-compliant behavior (FYI & Think Sheets), testing data, classroom data, grade reports, behavioral support plan, consents, evaluations, notice of IEP team meetings, eligibility statements, and placement determinations.
- 9. In September 2019, the Parent received the following four documents that were not part of the records delivered on June 25, 2019: (1) January 12, 2018 IEP meeting minutes; (2) the Confidential Assistive Technology Assessment dated June 18, 2018; (3) the annual Measurable Goals Progress Report dated June 12, 2019; and (4) the Computer Generated Annual Measurable Goals Progress report dated between November 14, 2018 and June 10, 2019.
- 10. The Parent's legal counsel was unable to confirm which documents were received within 45 days of the Parent's request.
- 11. One June 18, 2018, an assistive technology evaluation report regarding the Student was completed. The assistive technology evaluation discussed the Student's use of an iPad, more specifically the "Lamp Words for Life" program. The evaluator noted that the Student had a concern regarding being able to block out background noise by using headphones. The District has provided the Student with an iPad specifically to use "Lamp Words for Life".
- 12. The Parent has voiced concerns during IEP team meetings about the Student's communication skills and need for assistive technology.

# IV. DISCUSSION

The Parent alleges that the District violated the IDEA by failing to provide the Student's educational records for inspection and review within the timeline required by the IDEA. Educational records refer to all records pertaining to the identification, evaluation, and placement of a child.<sup>2</sup> A school district must provide a parent with an opportunity to inspect and review their

student's educational records without unnecessary delay and before any meeting regarding the student's IEP, and in no case more than 45 days after the request is made.<sup>3</sup>

Here, the Parent's legal counsel first requested the Student's educational records on May 24, 2019. Receipt of the request failed due to problems with the transmission by facsimile. Thereafter, the Parent's legal counsel contacted the District directly on May 28, 2019 and requested the Student's records. Assuming the earlier May 24, 2019 requested date started the timeline, the District was required to provide educational records no later than July 8, 2019.

The return receipt document and data retrieved from the U.S. Post Office indicate that the Parent, through their legal counsel, received responsive documents on June 25, 2019. The package of documents consisted of 144 of 148 documents in the Student's educational records. The District delivered these documents within 45 days and without any unnecessary delay. Four documents were delivered to the Parent later, in September 2019. Two documents (annual measurable goal documents) were created after the May 24, 2019 request. The two documents that were created prior to the records request that were not delivered to the Parent until September 2019 consisted of meeting minutes from a January 12, 2018 IEP team meeting and an assistive technology assessment from June 18, 2018. Any delay in providing these two records was minor, did not significantly impede the parent's ability to participate in the IEP process, and there is no indication that the delayed delivery of the assistive technology assessment reflected any failure on the part of the District to provide the assistive technology recommended in the 2018 assessment (e.g., use of the "Lamp Words for Life" application on an iPad).

The District timely provided records to the Parent for review and inspection within the 45 day time limit. This allegation is not substantiated.

### V. CORRECTIVE ACTION

In the Matter of McMinnville School District Case No.19-054-032

The Department does not order corrective action in this matter.
