FINDINGS OF FACT

1. On November 7, 2019, attorney Christine Furrer filed a Request for Due Process Hearing with the Oregon Department of Education (ODE) on behalf of Student and Parents. ODE subsequently referred the request to the Office of Administrative Hearings (OAH). The OAH assigned the case to Administrative Law Judge (ALJ) C. Meerdink.

2. On November 19, 2019, ALJ John Mann held a prehearing conference (PHC), with Ms. Furrer representing Student and Parents. Attorney Kelly Noor represented the District. During the PHC, the informed ALJ Mann that they intended to pursue mediation and were hopeful that the matter could be resolved. The parties agreed to schedule a hearing for December 9 through 13, 2019.

3. On November 27, 2019, Ms. Furrer notified the OAH that the parties had executed a settlement agreement resolving all matters in this case. Ms. Furrer requested that the Request for Due Process Hearing be dismissed with prejudice.

ORDER

Student's November 7, 2019 Request for Due Process Hearing in the above-captioned matter is **DISMISSED** with prejudice.
