HISTORY OF THE CASE

On November 9, 2021, Ms. Diane Wiscarson and Ms. Taylar Lewis, counsel for Parents, filed a Due Process Complaint with the Oregon Department of Education (ODE) on behalf of Student R.V. and Parents. ODE subsequently referred the request to the Office of Administrative Hearings (OAH). The OAH assigned the case to Administrative Law Judge (ALJ) Jessica E. Toth for hearing.

On February 3, 2022, Ms. Lewis notified the OAH, via email which included the school district's counsel, that Parent requested that OAH issue a final order dismissing the matter with prejudice.

ORDER

The November 9, 2021 Due Process Complaint in the above-captioned matter is **DISMISSED** with prejudice and all upcoming dates associated with the matter have been vacated by the OAH.
