- Due to the challenges this school year has posed, the December 31, 2021 deadline for initial claims is no longer a requirement.

The mandatory Training Webinar is now available on the Reimbursement Grant webpage. This is a recorded webinar. Please view as your schedule allows. After viewing is complete, each grantee must fill out a Reimbursement Grant Attestation Form.

Before Farm to CNP claims can be approved, returning sponsors must complete a Final Report from last biennium and new sponsors must complete a Baseline Report.

## FFVP SY 2021-2022 Updates

- FFVP subgrants have been built in EGMS and are currently marked as "on hold." Once agreements are signed and returned we will remove the holds on the FFVP awards.
- In the meantime, please continue to submit claims to FarmtoCNP@ode.state.or.us according to the SY 2021-2022 FFVP timeline. October 2021 claims are due Thursday, December 30, 2021. Due to the fact that subgrants are currently "on hold" in EGMS, we will allow EGMS entry after these deadlines but grantees are still responsible for turning their claims in to us at FarmtoCNP@ode.state.or.us by the listed deadlines.
- Please email us at FarmtoCNP@ode.state.or.us if your school is no longer planning to offer FFVP service or SY 2021-2022 so we can reallocate the funds to schools that are offering FFVP service.
- Please complete the mandatory annual FFVP training before submitting your first FFVP claim.

Course Title: ODE - Fresh Fruit and Vegetable Program (FFVP) 2021-2022 Training
Course Description: Annual training course for ODE's Fresh Fruit and Vegetable Program for the 2021-2022 school year.

Mandatory or Optional? - This course is mandatory to participate in the SY 21-22 Fresh Fruit and Vegetable Program and must be completed before submitting your first FFVP claim.

How do I enroll in the course? - It's easy! Follow these steps:

- Create a free Oregon Workday Extended Enterprise Learner account. Tips: Make sure to create account before trying to login. Make sure to select the 'Oregon Department of Education' affiliation. (View this job aid video if you need assistance creating an account, or follow the instructions on this pdf).
- Search for course title by clicking 'browse learning content,' then type 'ODE FFVP' in search box, select course and click 'Start Course.'
- Your participation will be recorded once the course is complete.

Please note: If you have a Workday account through your school district or organization, you will need to create a separate ODE Extended Enterprise Learner account. You will only be able to complete ODE courses through Workday Oregon.

The Youth Grow team at Growing Gardens demonstrated how to make salsa verde at 6 schools, and sent 316 salsa verde kits home for kids to cook with their families! New Seasons market donated about 1000 lbs of fresh produce (tomatillos, onions, peppers, cilantro and lime) to supplement what students grew in their school gardens. The lesson celebrated culturally-specific food and inspired students to taste fresh produce.

Here's what Youth Grow Educator Allison Yoder said about the project:
"My green salsa lessons were a huge hit and so much fun! Having take home cooking kits for the students felt really powerful. Students were so engaged and asked lots of questions about the cooking process, since they knew they'd be making the recipe at home. I got a ton of positive feedback from the students about how much they loved the salsa. Students said, 'I want to drink that!' and 'I give it an infinity out of 10!'."
