



Executive Summary of previous meeting



Updates

- Board approved IRST nominees
- Participation grants: \$2,000/month
- Legislature adjourned AMP budget
- Potential joint meeting with IRST this fall

Baseline and Trend Monitoring for Hydrologic Disconnection:

- Monitoring methods based off of Dube et al. (2010) and Martin (2009).
- Purpose: to establish a baseline, & to monitor & report the change in hydrologic connectivity over time as the FRIA is implemented.
- The overarching goal is to ensure that all forest roads and landings shall be hydrologically disconnected to the maximum extent feasible from waters of the state. The AMPC shall use the results of this monitoring to develop regional goals consistent with that monitoring.

<u>Tour focus</u>: start thinking about how to do this; examine fish passage. (NOT "are rules implemented correctly (compliance)?")
