

Utility Permit and Cultural Resource Review Notification

Note: This form may be used by a utility company to notify a tribe of the intended installation of a utility line including moving or repositioning existing lines or poles ("install a utility line") on state highway right of way. The information collected may be used to complete the forms needed to obtain a permit to install a utility line on state highway right of way and is not submitted to the Oregon Department of Transportation. CULTURAL RESOURCE REVIEW REQUEST

The utility company listed below intends to install a utility line on state highway right of way that is likely to include ground disturbance. The utility company has or will verify the presence/absence of cultural resources based on information available from the State Historic Preservation Office (SHPO). In addition, the utility company requests input on cultural resources that may be known to your Tribe but not in the SHPO database. Please complete and return this form to the utility company contact person within 30 calendar days of the date of this request. The tribal contact may attach a letter or email providing input on cultural resources in the intended work location in lieu of completing this form.
