Awab Al-Rawe Oregon Health Authority

Awab Al-Rawe was born in Baghdad, Iraq. Prior to leaving Iraq as a refugee, he lived, studied, and worked in multiple cities across the Middle East. After graduating high school, he volunteered with the UN and Red Cross/Crescent in Syria such providing interpretation for other refugees. Al-Rawe earned his B.A. from the University of Oregon (UO) in International Relations and Diplomacy and his M.S. from the UO School of Law in Conflict and Dispute Resolution. During his studies, Al-Rawe had

multiple positions such as consultant, program administrator, and academic advisor. He also served as the President of the Arab Student Union where he initiated several community engagement and dialogue campaigns with local residents, businesses, and organizations. He was awarded the MLK Jr. Award for leading a Jewish-Muslim dialogue program. Al-Rawe's recent work experience included working with the Department of Human Services as a family coach and an ombudsman where he investigated complaints from constituents regarding state DHS programs. Shortly after, he was recruited by the Eugene Police Department to serve as the first non-citizen Police Officer in the history of the department. Due to trauma and cultural barriers, Al-Rawe returned to state service in 2019 as an Ombudsperson with the Oregon Health Authority where he currently serves.



Shelagh Baird Samaritan Health Services

Shelagh Baird is the Community Health Improvement Program Specialist for Samaritan Health Services in Lincoln County. She came to this position circuitously: she earned her undergraduate degree in Politics and Journalism at the University of California, Santa Cruz, and upon graduating, promptly set sail as a deck hand, fisherman, and Medical Person In Charge on the NOAA Ship Miller Freeman. Shelagh's first-hand experiences with the challenges of providing medical care and promoting preventive health in extreme environments lead her to a career in

public health. After spending two years supporting oceanographic fisheries research and serving as the shipboard Medical Person in Charge in the Bering Sea and Aleutian Islands, she rejoined the landlubbers and studied Community-Oriented Public Health Practice and International Health at the University of Washington. In the nearly 15 years since earning her Master of Public Health, Shelagh has worked in international health, coordinating operations research that supported the Mozambican Ministry of Health in rolling out HIV/AIDS prevention and treatment programs, as a health care analyst in health metrics development and evaluation, as an independent reviewer for a large, national Institutional Review Board, and has broad experience conducting needs assessments, collecting and analyzing qualitative data, developing grants, and writing and editing professional copy.
