OEBB's mandatory Open Enrollment begins August 15, 2023.

You MUST enroll during this Open Enrollment period.

Everyone needs to make medical, dental, and vision plan elections for the 2023-24 plan year. Even if you want to keep the same plans, you must log in and select them.

Disability options are changing.

Several of OEBB's short-term disability (STD) and long-term disability (LTD) plans will end September 30, 2023. If your current STD or LTD plan will no longer be available, you will need to enroll in another plan to have OEBB disability coverage for the 2023-24 plan year.

If your current STD or LTD plan is still available for 2023-24, you do not need to re-enroll in those or in other optional plans such as life insurance, AD&D, or long-term care insurance. Any optional plan enrollments still available to you will carry forward into 2023-24.

Remember, Open Enrollment is the one time each year you can make changes to your benefit elections without experiencing a major life event (known as a QSC or Qualified Status Change). Please take a moment to review your options. We want you to have the best coverage available for your needs.
