Welcome and introductions - Silas Halloran-Steiner

# Approval of minutes – Silas Halloran-Steiner

Sara reviewed action items from the May 17<sup>th</sup> meeting minutes.

- 1. Add work plan activity for seeking additional funding sources. (This was added as a potential subcommittee activity pending guidance from PHAB for a future meeting.)
- 2. Provide definition of health equity included in Public Health Modernization Manual. (Included in the meeting packet.)
- 3. Tricia and Jeff to explore equity definitions or frameworks that might be applicable to this subcommittee's work.
- 4. Explore feasibility of including BERK drivers in funding formula. (Racial/ethnic diversity driver and poverty driver included as equity measures in example funding formula framework.)
- 5. Provide additional detail on county general fund contributions. (Included in meeting packet.)
- 6. Provide additional information about total amount currently distributed through Program Elements, and about state/local split of funding. (This conversation will be tabled for a future meeting, after the initial funding formula framework is complete.)

Tricia asked why the amount of current state public health funding to counties through Program Elements is not being provided. The funding formula required in House Bill 3100 is for new monies for LPHAs to implement public health modernization and does not affect current funding streams.

Subcommittee members voted to approve the May 17th, 2016 subcommittee meeting minutes. All in favor.

#### Review draft funding formula- Subcommittee members

HB 3100 states that the formula must include baseline funding (county population, burden of disease, and health status). Race/ethnicity and poverty are not required but were added to the framework in response to subcommittee recommendations for additional health equity indicators.

PHD provided an overview of the methodology for the funding formula example.

Silas questioned whether the model is too ambitious, with too many indicators. He suggested including a funding floor and weighting county population higher than other indicators.

PHD clarified that with the current rankings, a "1" indicates the lowest level of need and a "34" indicates the highest level of need. The subcommittee recommended that this be noted on the funding formula example.

Alejandro stated that race/ethnicity may be correlated with burden of disease and poverty. He asked if there is a way to address potential overlap between these indicators. Jeff stated that based on other data in public health there is a strong correlation between race/ethnicity and health disparities. Tricia says it is more complex than this and depends on the disease or health behavior. YPLL may be a simpler measure.

It was recommended by Jeff and Tricia to include a cultural competency indicator.

Silas asked if the funding formula framework needs to be completed by June 30<sup>th</sup> or whether PHD can submit a straw proposal. PHD will submit a straw proposal, and the subcommittee can continue to work on the funding formula over the coming months.

Akiko and Jeff indicated their support for including the added indicators (race/ethnicity and poverty). Tricia suggested adding limited English proficiency and community complexity. Language access is a civil right and LPHAs must comply with the law. Community complexity could look at lead and air toxics, or jurisdictions with multiple cities, school districts and health care systems. Silas stated that frontier counties encounter geographic complexities. Additional options for indicators include education and unemployment.

Jeff asked for confirmation that the subcommittee can continue to discuss options for adding metrics and to allocate percentages across indicators. This was confirmed.

There was consensus to support the general funding formula framework without the percentages for allocating funds across indicators and to add limited English proficiency as an indicator.

Considerations:

- The subcommittee identified achieving equity as a guiding principle for all decisions made about the funding formula.
- House Bill 3100 requires that the funding formula include mechanisms for awarding matching funds for county contributions to support public health and for awarding incentives to counties. These components of the funding formula will not be in place for the 2017-19 biennium.
- The subcommittee will consider the funding formula as it relates to findings from the public health modernization assessment and priorities for the 2017 legislative session.
