AGENDA ITEM #2 – Work session: Strategy narrowing and writing

Strategy Review: Trilby explained the dynamics of the working excel document including color coding and strategy order and narrowing process. Emileigh captured wording notes and changes in working excel strategy document. Representatives from each of the of the workgroup's took turns talking through

Physical environment

Cara began by reading each of the new parred down/combined strategies from the Physical Environment workgroup's last session and the rationale from the worksheet. The subcommittee then continued made the following recommendations.

- There was new language added to the built environment strategy for Physical Environment.
- The group discussed the equity strategy in more depth. Emileigh suggested combining with another. Carolina responded that's it was important for the Equity strategy to be on its own to not be watered down and assure that other meanings cannot be taken out of it.

- Strategy was left on its own.
- Carolina suggested combining Physical Environment #3 land use/transportation and #4 housing/transportation.
- Group agreed.
- Discussed the addition of another strategy tied to the 3rd grade reading level outcome indicator. Holding place in overarching Economic Drivers priority area outside of identified sub-priority areas.
- Combined strategies 7 and 8 as water and climate are related. Carolina explained that 7 has two separate components.
- Cara talked about the Oregon Water Enhancement Board 100-year strategy.

Economic viability

Emileigh explained how the Economic Viability strategies were worked through.

- General; Combine 8&6 or 6&7, Combine 1a&b, 2,
- In cost of caregiving; a similar strategy in ATTS group under goal one, strategy #2;
- Employment related strategies can be put on hold under coc and considered under employment related.
- Should there be more specificity outlined in what we mean by data collection?
- Add to #10 in cost of caregiving new language Increase understanding of barriers associated with the costs of childcare.
- Trilby Committee (mentioned in #18) is designing a program that is redesigning the cost of healthcare model.
- Group decided to drop the cost of health care category.

Employment related strategies

- Living wage is common theme amongst category
- Lucia employment strategies should be linked to having employers that_____

Food Insecurity

- There is strategy that is similar to Access to care strategy under their goal #1 Liz will go to that group and propose to include language from similar food insecurity strategy.
- Difference b/w #'s 4 and 5 discussed and discussion about combining.
- Trilby we need to get these lists more refined. We can do this via basecamp between meetings, touch base with Emileigh.
