# AGENDA ITEM #1 – Welcome, agenda overview, and subcommittee business

Trilby opened the meeting and invited everyone to introduce themselves. Subcommittee members introduced themselves. Trilby set the stage for strategy identification by reviewing the strategy criteria. The subcommittee has identified goals and are working on outcome indicators and now is moving forward with our strategies. Between now and February, the subcommittee will develop 10 to 15 strategies at the policy, community, and individual level relating to the two goals.

# AGENDA ITEM #2 – Breakout sessions

The subcommittee broke out into the four workgroups utilizing Zoom to discuss indicators. The four work groups are Economic Viability, Food Insecurity, Physical Environment, and Cost of Care Giving. A discussion was held in each workgroup to choose 1 -2 indicators per workgroup.

### AGENDA ITEM #3 – Report out to full subcommittee

The four committees proposed the following indicators:

### Food Insecurity

- 1. Free/reduced price lunch for 8th graders (Oregon Healthy Teens)
- 2. Past year anyone in household unable to get food when really needed (possibly PRAPARE survey)

## Economic viability

- 1. Self-sufficiency standard component measure every 3 years, exploring if there is equivalent for an annual measure
- 2. Percent of adults living in economic disadvantage by region (possibly BRFSS)

Physical environment

1. Housing cost burden – Percent of households paying 30% or more of income by rent group (possibly American Community Survey)

# Cost of Care Giving

- 1. Proportion of income spent on caregiving (goal is to break this down further into types of care) Could serve as a proxy, in some ways, for availability
- 2. Average wage of all care workers
- 3. Availability of child care (# slots, child care desert)

# **AGENDA ITEM #4 WRAP UP & NEXT STEPS**

Next month the group will move into the discussion on strategies. There were two sources mentioned to look at for ideas. The first was the Association of State and Territorial Health Officials (ASTHO) Food, Housing, and Transportation Initiatives Aim to Reduce Health Disparities. There is a website with an interactive map of place based-strategies as well as a recent blog post highlighting initiatives from other states in healthy food access, transportation, and housing. The second source mentioned was the data gathered from the first round of community engagement that was conducted to prioritize strategic issues for the SHIP. That document is located in the Data folder under Docs and Files on Basecamp and titled "Qualitative feedback from community.state health assessment.pdf." It is a long document, however Christy did some initial coding for economic drivers within the document.
