1. To comply with statutory changes from the passage of House Bill 2546 (electronic cigarette law), and to clarify the rules and procedures for implementing and enforcing the Indoor Clean Air Act, a rulemaking process has been underway for the past two months.

 The Multnomah County Board of County Commissioners is considering a tobacco retail licensing system to help local businesses comply with local, state and federal laws. The tobacco retail licensing system being discussed would require all Multnomah County retailers of tobacco and nicotine products to pay an annual fee in order to sell these products. The Board plans to hold two public hearings on October 20th, one in Portland at the Multnomah Building first floor board room (501 SE Hawthorne at 10:00 am) and one in East County (David Douglas High School 5pm – 7pm), to gather input.

Diane Waldo made the motion to recommend the budget. Kevin Ewanchyna and Carrie Nyssen seconded the motion, and it was agreed to by all TRAC members present.

The committee discussed TRAC membership, the Executive Order and meeting frequency. TRAC members expressed an interest in meeting quarterly and revisiting the Executive Order for possible revisions. TRAC members discussed the need for a co-chair to accompany OHA co-chair Karen Girard. The committee identified Luis Rodriguez from the American Cancer Society- Cancer Action Network as the TRAC co-chair.

Priorities from the recently released State Health Improvement Plan

<u>plan.pdf</u>) were discussed, as tobacco prevalence is identified as one of Oregon's seven priority areas.
