Amy Slater motioned to approve, Dr. Serfin second. Vote passes

Big 1 Workgroup – Mac Cook
Since Jan 2020 OHSU

- 86 patients – median length of stay- 23 hours
 - Median transfer cost- \$56K
 - OHSU billed patients \$4.8m

Dr. Cook wants all the hospitals to feel supported in the change of managing BIG1 patients at the hospital within their community.
This guidance does not preclude transfer, the recommended hold time is 6 hours.
each patient should get that consideration, if a hospital does not have the resources, they can still transfer, but this is a guideline to use when appropriate.
It was recommended that the ATABs present and discuss at their next meetings. The should collect responses and submit to Stella Rausch-Scott. Stella will collect all responses and send them to the

workgroup for review.

OHA EMS Modernization Update- Dana Selover

EMS Mobilization – The bill would have the Oregon Trauma System be the template for other time sensitive emergencies.

OHA EMS/TS currently works with HSPR to some extent on ambulance surge needs but this bill would create legality of statute and rules for such needs. We have a thin agreement in place, but it's not a good long-term solution.

Licensing of non-transporting agencies. We are one of 3-4 states that don't regulate fire agencies. It is unclear if that piece will be included.

This is not OHA's bill, so we are in communication with Rep Graber's office and will support them. These bills should start dropping in Feb.

EMSC- Update- Matt Philbrick

- NESMQA- this was discussed a lot earlier, so I will skip what was discussed yesterday at EMSC.
- Make the Right Call – card (printable) can be provided to people in community if needed
- Agencies and Hospitals are seeing a rise in RSV, COVID and Flu patients currently. Peds readiness program pedsreadyprogram.org
- New TikTok Trend- high dose Benadryl in peds. Seeing this rise at hospitals across the state.
- Equipment that has been provided to agencies – on website and in Q4 report.
- Looking for EMS Tribal rep to be on this committee
- HeroKids registry- new videos created (complex medical histories, behavioral health etc.)

State EMS Committee Update- Jim Cole

- Review of EMS Committee agenda items, NEMSQA data, hospital wall wait times, vacancies.

Oregon Trauma Registry Data - Andey Nunes

- Review of agencies reporting to 3.5
- Trauma integration is established between the two systems (Elite, and ESO Trauma 1). This was a home-grown patch, ESO is phasing out the old software, and when they do, this integration will go away.
- OR-EMSS needs to send 3.5 records in 3.4 format to OTR or the data needs to be converted en route.
- ImageTrend has said there is a fix they have developed, but there is no implementation date.
- Data team is working on another option using Rhapsody- still needs implementation and testing.
- ORT Software RFP
 - o Out for bid- ImageTend is current successful proposer
 - o October to begin contract discussion.
- OTR 2024 Data Standards

- 9: Collaborate care no matter where a patient comes from or goes in ATAB 9, they all get the same care. The BIG 1 info presented today fits in with the project they are doing.
