Re: Summary of Nurse Staffing Audits for 2009

As part of its efforts to ensure that Oregonians have wide access to the health care they need and that it will be safe and of high quality, the Public Health Division, Health Care Regulation and Quality Improvement Program has completed its findings for the 2009 Hospital Nurse Staffing Audit in accordance with ORS 441.170(3).

In an effort to streamline the process for these reviews, nurse staffing surveys were integrated into routine, onsite survey work evaluating compliance with state licensure rules and federal Medicare conditions of participation and coverage, or during complaint investigations.

Significant improvements in compliance with nurse staffing laws have been observed since 2005 with fewer and less serious citations being issued. Seventeen percent of the licensed facilities in Oregon were audited (12 hospitals) with only three facilities having deficiencies cited and no civil penalties assessed. Of the 12 audits performed, six audits were specifically for nurse staffing complaints received in 2009. The common deficiencies cited included failure to document according to administrative rules and failure to ensure that the nurse staffing committee monitored, evaluated, modified and re-approved a nurse staffing plan.

For 2010, we will continue to integrate nurse staffing surveys with our other hospital survey activities and perform full nurse staffing audits in response to nurse staffing complaints.
