Welcome & Staff Introductions <ul style="list-style-type: none">• Introductions of OHA staff and the CRRU training team Highlighted Topics <ul style="list-style-type: none">• Setting the institution (AICs, LTCFs, etc)<ul style="list-style-type: none">• Important to set the institution especially for Adults in Custody (AIC), so they can be removed easier from the counts in a jurisdiction. This can affect risk level metrics. Timestamp: 1:15• Workflow change around deadline to set the institution. Now on Friday versus Monday. This gives time for accurate counts and proper notifications of leadership if needed. - Negative faxed results can be ignored. We are no longer recording them as suspect cases. If faxed positive results, query Opera to see if cases have already been created, if not, create a case and manually enter in faxed lab results in the cases Opera record. Timestamp: 12:32

How to search for a negative result

- Demo on how to search for negative test result. Can be useful if case has tested negative in the last 45 days. Timestamp: 19:50

Vaccine tab review

- Vaccines administered in OR can be tracked using the OR State Alert system.
- Up to date and Onset check box fields in Opera are based on whether the case has received their last dose of vaccine. No is selected if its been less than 14 days since the cases last dose. Yes is selected if it's been more than 14 days since the cases last dose. Timestamp: 27:41
- Demo on selecting the up to date or onset box fields in Opera. Timestamp: 28:26
- Manually add vaccine information if unable to query the Alert system or if the case received their vaccination out of state: Timestamp: 30:33
- Demo on manually adding vaccine information in Opera. Timestamp: 30:15

- Demo on setting the school in the worksite field in Opera. Timestamp: 48:15
- Adding new and revising risk questions. This was started in November 2020 but was paused due to the surge. The updated and revised questions were agreed upon by the LPHA's and affiliates. Timestamp:50:01
