I'm in Lane County, working for White Bird Clinic, and I am working with groups to coordinate incentives during vaccination (food, gift cards, etc.).
Jackson	Melanie Doshier	Prioritize shelter staff and providers for vaccinations, shelter residence are also prioritized. Not sure if campers are prioritized. Challenges getting vaccines delivered, moved to Portland area. Project Turnkey was announced for JaCo.
