Oregon Disaster Housing Task Force Meeting

Meeting Summary - Thursday January 7th at 2:30pm

Opening Remarks

Chair Kim Travis: Kim got the meeting underway at 2:34 p.m. and turned it over to Caleb Yant, Deputy Director at OHCS to provide brief opening comments, thanking everyone for all their contributions. He extended a special thank you to HUD, FEMA, and those that participated in last weeks' small group discussion.

- HUD Housing Impact Assessment Roger Jacobs, HUD
 The Impact Assessment will provide a pre and post disaster housing analysis based on existing data and outline considerations for recovery efforts. The Housing Impact Assessment will be completed in February.
- <u>Disaster Housing Recovery Action Plan & Feedback</u>
 Participants were divided into three small breakout rooms to discuss key topics:
 Manufactured Home Parks and Interim Housing. The groups identified barriers and constraints, as well as some near term actions to consider in the Disaster Housing Recovery Action Plan.
- OEM Updates Stan Thomas and Joseph Murray
 Joseph Murray noted that for non-congregate sheltering, Oregon DHS is currently utilizing
 58 hotels/motels, comprised of 543 rooms, housing 1020 people who were affected by the
 windstorm-firestorm event. The state's Disaster Case Management application is under
 FEMA review. If successful, it will result in 24 case managers for about 18 months.

As of COB on Monday – the most recent report available – FEMA had approved approximately \$32.2 million in the Individuals and Households Program (IHP), comprised of \$25.6 million in Housing Assistance and \$6.6 million in Other Needs Assistance.

With the FEMA Direct Housing Program 244 approved households and 71 families "licensed-in" that include 178 individuals. The approved numbers are down as families find other options on their own. As of Monday morning, the SBA had approved 522 low interest loans for almost \$57.2 million. Approximately 2000 loan applications are still under review.

Joseph referenced FEMA's Public Assistance (PA) program and eligible applicants: state agencies, units of local government, special government districts, and some nonprofits. OEM has received just over 150 Requests for Public Assistance (RPAs). FEMA extended deadline for filing RPAs until January 13.

The Hazard Mitigation Grant Program (HMGP) has essentially the same eligible applicants as PA. About \$43 million was still available as of the end of the calendar year, i.e., the difference between the total funds available and funds accounted for by NOIs already filed. HMGP requires a 25% non-federal match. Pre-applications are due to July 1.

Martin Campos-Davis, Executive Director of Oregon Human Development talked about their work to get money in people's hands without just handing them cash. They provided over \$200,000 in gift cards averaging of about \$250 each so people could go out and get what they needed. He talked about other organizations they are working with to conduct farmworker outreach.
