Meeting Summary – Thursday November 12th at 2:30pm

Opening Remarks

Chair Kim Travis: The meeting that had been scheduled for Thanksgiving will be canceled; the next meeting will be on December 10. A lot of work will be occurring in small groups between now and then, including the development of a framework for a Disaster Housing Recovery Action Plan.

She then introduced Caleb Yant and he spoke a bit about Kenny's work and the transition to Kim taking the lead with the ODHTF. He is thrilled about Kim stepping into this role. He noted Kim's understanding of land use planning. Caleb is the Acting Director at OHCS. Margaret is taking a leave of absence for approximately one month to assist in the President Elect Biden's transition involving HUD.

FEMA External Outreach Site #1 remains open 8 a.m. to 6 p.m. Monday through Saturday at Central High School, 815 South Oakdale Ave., Medford, Oregon 97501.

Joseph also provided the following update on the FEMA EOS facilities: FEMA continues to do group site assessments in Jackson County and is also doing one in Mill City.

FEMA has approved about \$25.4 million in IA overall, comprised of approximately \$19.8 million in Housing Assistance and about \$5.6 million in Other Needs Assistance. In HA, there have been 428 maximum awards so far.

The SBA has approved 329 loan applications for about \$37.7 million.

American Red Cross non-congregate shelter numbers have risen a bit recently; 1038 clients in 547 motel rooms: people are coming-in from the cold or leaving situations where they are staying with family or friends.

- <u>FEMA</u> Toney Rainey gave the update for FEMA. He noted that Lincoln County has been added for the direct housing program. He talked about the challenges of Direct Housing in each of the four counties. FEMA hopes to have at least one family leased-in by Nov. 19.

Mike Savara shared his screen; he explained the \$7,000 per household limit for this grant. OHCS is looking to determine what changes they can make to this program to better fit the current needs. He noted people who are not able to access FEMA resources perhaps could become the primary audience for this program. OHCS is submitting a temporary rule change to fund renter households. They have 1,300 applications thus far. If they lower the award amount to \$6,500, the program will be able to serve more people. OHCS is engaging a community organization with good ties into the Latinx community. Nicole
