### Membership updates:

When Title II membership changes are needed, all three Title II partners must be notified.

#### TSPC:

Notify TSPC (<u>candace.robbecke@tspc.oregon.gov</u>) of the change needed. Include name, title, phone number, and whether the person is a Primary or Secondary member.

#### Title II - Pearson:

To modify permissions through edReports:

- 1) Go to edReports:
- 2) Log in, select [Manage users];
- 3) Select [Add New Users];
- 4) Follow prompts;
- 5) Notify the contact to look for an email from <a href="mailto:edreports@nesinc.com">edreports@nesinc.com</a> and that they must act on the invitation within two weeks; and
- 6) Follow up to ensure the contact acted on the invitation. If they don't, they will not receive Title II information from Pearson.

To modify permissions without going through edReports:
